PETITION FOR PERMANENT FINAL PROTECTIVE ORDER (Family Law § 4-506(k))

 § 3-311 (attempted first degree sexual offense)*, § 3-312 (attempted second degree sexual offense)*; or
 for conspiracy or solicitation to commit murder
