The Maryland Mediation and Conflict Resolution Office (MACRO) is a 40-member multi-disciplinary group created and chaired by the Honorable Robert M. Bell, Chief Judge of Maryland's highest court. MACRO is working to advance the appropriate use of mediation, arbitration and other dispute resolution processes in every sector of society, including the business sector. As part of this effort, MACRO has formed a Business Alternative Dispute Resolution (ADR) Initiative to promote ADR throughout Maryland's business community.

The Maryland Business ADR Initiative urges Maryland businesses to adopt the Business ADR Pledge. This Pledge obliges subscribing companies to seriously explore negotiation, mediation, arbitration or other ADR processes in conflicts arising with other Pledge signatories before pursuing full-scale litigation. ### The Pledge

We recognize that for many disputes there is a less expensive, more effective method of resolution than the traditional lawsuit. Alternative dispute resolution (ADR) procedures often spare businesses the high costs of litigation, preserve business relationships and result in solutions not available in court. In recognition of the foregoing, we subscribe to the following statements of principle on behalf of our company (and any domestic subsidiaries listed above).

In the event of a business dispute between our company and another company which has made or will then make a similar statement, we are prepared to explore with that other party resolution of the dispute through negotiation or ADR techniques before pursuing full-scale litigation. If either party believes that that dispute is not suitable for ADR techniques, or if such techniques do not produce results satisfactory to the disputants, either party may proceed with litigation.\*
