Dear Interested Party:

The following consists of questions received in reference to RFP No. K10-0055-19, Flat Panel Docket Display System and the Maryland Judiciary's response.

**Q:** Could you provide me with the make and the model# for the server rack that you are currently using?

**A:** The cabinet is a Vero brand cabinet. It is a freestanding cabinet with front and rear doors. Cabinet is approximately 23" wide by 33" deep. The cabinet has standard 19" rails for mounting equipment.

**Q:** On page 6, the proposal states, "All panels will have field replaceable light sources." Could you elaborate further on this requirement?

**A:** The LCD panels use a light source behind the panel to create the image. This light is usually a specialized Compact Fluorescent Lamp. If the lamp burns out we would like to be able to replace it on site without returning the panel to the vendor for replacement.

**Q:** Could you provide more detailed technical specifications for the current Docket Information System on the JIS mainframe system?

**A:** The question is unclear. The data resides on UCS and not on the Mainframe. Our current experience for providing data for Docket Display System is as follows:

- Vendor's Docket Display System is not integrated with UCS;
- There is scheduling of court events data feed from the UCS via FTP once a day for the next day or same day based on data transfer time requirements;
- There is no information exchange from the vendor's Docket Display System back to UCS

**Q:** Primarily in what database platform is the Docket Information stored?

**A:** The vendor provides information for their server, including a login and password for the FTP process.

**Q:** What type of access would JIS be providing to the Docket Information on the mainframe (e.g. direct database access, a timed export, etc.)?

**A:** The question is unclear. As noted above, JIS transfers daily scheduled court docket data as a flat file via FTP.

**Q:** In what format would this data be available in? Could you provide a sample of the Docket Information to be downloaded and displayed?
