A MESSAGE FROM THE WASHINGTON COUNTY DEPARTMENT OF SOCIAL SERVICES

In 2000, Washington County Department of Social Services (DSS) partnered with the courts to develop the Generous Jurors program to assist with non-funded costs for children in foster care.

In 2011, Washington County DSS opened the Sunshine Center Family Visitation Program in an effort to offer families and children in foster care a more home-like environment in which to have their visits. At the Sunshine Center, families can engage in familiar and comforting activities like: family meals, crafts, outside play, and pet visits, if pets have been with the family for a long time.

FREQUENTLY ASKED QUESTIONS

Jury Announcement

Check after 4:30 pm every evening 301-739-3440

Arrival

Please arrive prior to 8:45 am on days of scheduled service. Bring your badge and state-issued identification. Work certification provided on request.

Pay - payment by check (mailed the week after service)

Per diem: \$30.00/day

Overtime: (if trial goes past 6:00 pm): additional \$5.00/day Mileage: \$0.30/mile (round-trip from home to courthouse)

Parking (updated: 06.27.24)

FREE PARKING is provided **ONLY** in the University District Parking Deck located at <u>25 North Potomac Street</u>.

Please bring your parking stub with you each day for validation at check-in

Handicap parking - call the Jury Clerk as soon a possible to reserve a spot

Where do I report each day that I am scheduled?

You will "check in" on the first floor of the courthouse, in the hallway outside of Room 212. The jury clerk will then direct you to the correct courtroom.

How long is my term of service?

Trial jurors will serve 1 week or service on a jury panel. The judge will inform you if the trial will last for more than one day.

How long will my day last?

Jury selection generally takes about 1.5 hours. There is no way to accurately predict how long a trial may last.

Are there scheduled breaks?

The judge will try to accommodate breaks and a lunch recess, but the timing may vary based on the complexity of the trial and witness testimony.

How do I identify myself in the courtroom?

Always refer to yourself by using your reporting number; never use your name. Please respect the privacy of your fellow jurors and never share their names with others outside of the courtroom. If you lose your badge, please see the Jury Clerk, located in Room 212.

How should I dress?

You may dress casually, but conservatively. Shorts, hats (except for religious reasons), tank tops, halter tops, undershirts, and flip-flops are considered inappropriate. Jurors should also avoid appearing in uniforms or clothing displaying writing, such as logos, slogans, etc.

Can I bring my cellphone to court?

Yes, but it must be turned off during the trial and will be held by the bailiff during deliberations.

What if I am hearing impaired?

See the bailiff upon reporting to your assigned courtroom. They can provide you a hearing assistance device.

What is the inclement weather policy?

In the event of inclement weather on a morning you are scheduled to report for service, call the recorded announcement line at 301-739-3440 after 7:00 am to find out if your service has been canceled. If the information has not changed, report as scheduled.

Is my jury pay taxable?

The court will not issue a W-2 or 1099 since your pay will not exceed \$600.00. You should seek tax advice from a professional to determine if your jury pay is reportable.

What if my employer does not permit me to receive a jury stipend (pay)? (updated 06.04.24)

You will need to complete a Waiver of Juror Compensation form and submit it to the Jury Clerk. It cannot be donated to the Generous Juror Fund. (Jury Office Finance Manual)

What if I have an emergency?

Please call the jury clerk as soon as possible. If you do not call and do not show for your scheduled service, the judge may ask law enforcement to bring you to the court to explain your absence.
