1.1 PURPOSE

The purpose of this IFB is to provide information to bidders interested in submitting a bid to meet the State's requirements for furnish and delivery of approximately 129,100 Civil File Folders and 54,500 Special Proceedings File Folders. This IFB implies no obligation on the part of the Maryland Judiciary.

1.2 PROCUREMENT OFFICER – POINT OF CONTACT (POC) INFORMATION

The Maryland Judiciary may change the Procurement Officer at any time by written notice.

1.3 PROCUREMENT METHOD

This procurement shall be conducted under the Competitive Sealed Bidding process according to the Procurement Policy for the Maryland Judiciary.

1.4 CLOSING DATE

An unbound original must be received by the Procurement Officer at the address listed in the key information Summary Sheet by **September 25, 2018, 2:00 p.m. EST,** in order to be considered. Bids shall be marked **IFB No. K19-0035-90H; Civil and Special Proceedings File Folders,** on the outside of the envelope. An electronic version of the must be enclosed with the original bid. Electronic versions are to be labeled with the date, IFB title, IFB number, and bidder's name, and packaged with the original copy of the appropriate bid.

Requests for extensions of this date or time will not be granted. Bidders mailing bids should allow sufficient mail and internal delivery time to ensure timely receipt by the Issuing Office. Bids <u>may not</u> be submitted by e-mail or facsimile.

1.5 ABBREVIATIONS AND DEFINITIONS

For the purposes of this IFB, the following abbreviations or terms have the meanings indicated below:

- a. AOC means Administrative Office of the Courts
- b. Contract means the contract attached to this IFB as Attachment A
- c. Contractor means he selected bidder

- d. Days means calendar days
- e. Local Time means the Eastern Time Zone as observed by the State
- f. MBE means the Minority Business Enterprise currently so certified by the Maryland State Department of Transportation.
- g. Bidder means an entity that submits a bid in response to this IFB
- h. Procurement Officer means the State representative responsible for this IFB, for the determination of contract scope issues, and the only State representative who can authorize changes to the contract. IFB means the Invitation for Bids for **K19-0035-90H** dated September 05, 2018, including any and all amendments.
- i. Project Manager (PM) means State representative that serves as the technical manager for the resulting contract. The Project Manager monitors the daily activities of the contract and provides technical guidance to the Contractor
- j. State of Maryland regular business hours means 8:00 am 4:30 pm Monday Friday.

1.6 QUESTIONS/INQUIRIES

The Procurement Officer will accept written questions from prospective bidders via email (see Section 1.2). Time permitting, answers to all substantive questions that are not clearly specific only to the requestor, will be posted on the Maryland Judiciary and eMaryland Marketplace websites.

1.7 PROJECT MANAGER

The Project Manager monitors the daily activities of the contract and provides technical guidance to the Contractor. The contract Manager is: Rose Day

The AOC may change the Project Manager at any time by written notice to the Contractor.

1.8 CONTRACT TYPE

The contract resulting from this solicitation will be a firm fixed price contract.

1.9 TERM OF CONTRACT

The Contract resulting from this IFB shall be for a base period of three years. The AOC shall have the sole right to exercise up to two, one-year renewal options at its discretion. All prices for rates and terms as offered in Exhibit D are binding on the Contractor for the full term of the Contract, including renewal options.

In the event that Contractor's paper costs increase after the first year of the contract, the District Court, upon its receipt of a written notice by Contractor, requesting to pass on such increase, may elect to authorize a proportional increase of the contract price; providing, however, that such request is fully documented and supported in writing by the paper mill or paper distributor, The Contractor may only request one increase per year.

It is hereby understood by the parties that this escalation clause shall be exclusively employed for increases in paper cost, which may materialize over the duration of this Contract and may not be construed to allow any other alleged increases of operation expenses, overhead or profit, which may occur over the said duration. Contractor shall not pass on any increase of cost without the express approval of the Maryland Judiciary.

1.10 BID OPENING

The Procurement Officer shall hold all bids and modifications in a secure place until the due date, after which time the bids, will be opened in the presence of at least one other Judiciary employee and a bid tabulation will be prepared.

1.11 DURATION OF BID OFFER

Bids shall be valid and irrevocable for 180 days following the closing date for this IFB. This period may be extended by written agreement between a Bidder and the Procurement Officer.

1.12 REVISIONS TO THE IFB

If it becomes necessary to revise this IFB before the due date, amendments will be posted on the Maryland Judiciary and eMaryland Marketplace websites

Acknowledgment of the receipt of all amendments issued to this IFB must be stated in the transmittal letter accompanying the bid submission. Failure to acknowledge receipt of amendments does not relieve the bidder from complying with all terms of any such amendment.

1.13 CANCELLATION OF THE IFB; REJECTION OF ALL BIDS

The Procurement Officer may cancel this IFB, in whole or in part, whenever this action is determined to be in the Maryland Judiciary's best interest.

1.14 BID ACCEPTANCE

The State reserves the right to accept or reject any and all bids, in whole or in part, received in response to this IFB, or to waive or permit cure of minor irregularities. Bidders whose bids are not accepted will be notified in writing.

1.15 MULTIPLE OR ALTERNATIVE BIDS

Neither multiple nor alternative bids will be accepted.

1.16 INCURRED EXPENSES

The Judiciary will not be responsible for any costs incurred by a bidder in preparing and submitting a bid in response to this IFB.

1.17 PROTESTS

A bidder may protest the proposed award or the award of a contract for this procurement. Any protest must be filed in accordance with the Procurement Policy of the Maryland Judiciary.

1.18 PUBLIC INFORMATION ACT NOTICE

An Offeror shall give specific attention to the clear identification of those portions of its proposal that it considers confidential, proprietary commercial information or trade secrets, and provide justification why such materials, upon request, should not be disclosed by the Judiciary under the Public Information Act, Title 4, Subtitle 1, Part III of the General Provision Article of the Annotated Code of Maryland or Rules 16-901 through 16-912, the Court Access Rules.

Offerors are advised that, upon request for this information from a third party, the Procurement Officer is required to make an independent determination whether the information can be disclosed. Information which is claimed to be confidential is to be placed after the Title Page and before the Table of Contents in the Technical proposal and if applicable in the Financial proposal.

1.19 MINORITY BUSINESS ENTERPRISES ENCOURAGEMENT

Minority Business Enterprises (MBE) are encouraged to respond to this solicitation notice. It is the goal of the Maryland Judiciary that certified MBEs participate.

There is no MBE goal established for this solicitation.

1.20 COMPLIANCE WITH LAW; ARREARAGES

By submitting a bid in response to this IFB, the bidder, if selected for award, agrees that it will comply with all Federal, State, and local laws applicable to its activities and obligations under the contract. By submitting a bid in response to this IFB, the bidder shall be deemed to represent that it is not in arrears in the payment of any obligation due and owing the State of Maryland, including the payment of taxes and employee benefits, and, that it shall not become so in arrears during the term of the contract if selected for contract award.

1.21 BID/PROPOSAL AFFIDAVIT

A completed Bid/Proposal Affidavit must accompany any bid. A copy of this affidavit is included as Attachment B of this IFB.

1.22 MANDATORY CONTRACTUAL TERMS

By submitting a bid in response to this IFB, a bidder, **if selected for award**, shall be deemed to have agreed to and accepted all contract terms and conditions set forth in the state's Standard Contract Agreement included as Attachment C of this IFB. A bid that takes exception to these terms may be rejected.

1.23 CONTRACT AFFIDAVIT

All Bidders are advised that if a Contract is awarded as a result of this solicitation, the successful Bidder will be required to complete a Contract Affidavit. A copy of this Affidavit is included for informational purposes as Attachment C of this IFB. This Affidavit must be provided within five business days of notification of proposed Contract award.

1.24 VERIFICATION OF REGISTRATION AND TAX PAYMENT

Before a corporation can do business in the State of Maryland it must be registered with the Department of Assessments and Taxation, State Office Building, Room 803, 301 West Preston Street, Baltimore, Maryland 21201. It is strongly recommended that any potential bidder complete registration prior to the due date for receipt of bids. A bidder's failure to complete registration with the Department of Assessments and Taxation may disqualify an otherwise successful bidder from final consideration and recommendation for contract award.

1.25 BIDDER RESPONSIBILITIES

The State will enter into contractual agreement only with the selected bidder. The selected bidder shall be responsible for all products and services required by this IFB. All subcontractors must be identified and a complete description of their role relative to the bid must be included in the bidder's response. If a bidder that seeks to perform or provide the services required by this IFB is subsidiary of another entity, all information submitted by the bidder, such as but not limited to, references and financial reports, shall pertain exclusively to the bidder unless the parent organization will guarantee the performance of the subsidiary. If applicable, the bidder's response must contain an explicit statement that the parent organization will guarantee the performance of the subsidiary.

1.26 PAYMENTS BY ELECTRONIC FUNDS TRANSFER

By submitting a response to this solicitation, the Offerors agrees to accept payments by electronic funds transfer unless the State Comptroller's Office grants an exemption. The selected Offerors shall register using the COT/GAD X-10 Vendor Electronic Funds (EFT) Registration Request Form. Any request for exemption must be submitted to the State Comptroller's Office for approval at the address specified on the COT/GAD X-10 form and must include the business identification information as stated on the form and include the reason for the exemption. 2.1 GENERAL

2.1.1 The District Court of Maryland, is issuing this IFB to select a Contractor to provide all labor, materials, and expertise required to furnish and deliver approximately 129,000 Civil File Folders and approximately 54,500 Special Proceedings Folders to various District Court locations within the state of Maryland. The listed quantities are estimates only.

All folders MUST be delivered to all designated District Court locations no later than **December 11, 2018**. Refer to the attached Exhibit E for estimated delivery quantities and locations. All shipments shall be inside delivery. <u>Upon request samples can be viewed</u> at the 2003 C Commerce Park Drive, Annapolis, Maryland 21401. Please contact Karen Hoang (410) 260-1582.

Work shall be performed in accordance with the attached specifications and Maryland Judiciary Terms and Conditions.

2.2 CONTRACTOR RESPONSIBILITIES – STATEMENT OF WORK

The Contractor shall furnish and deliver Civil and Special Proceedings folders to various District Court locations within the state of Maryland. All work shall be performed in accordance with the specifications and samples.

2.3 SPECIFICATIONS

2.3.1 <u>The Civil File Folder must meet the minimum specifications as follows:</u>

• **Quantity and Size:**

129,000 Shelf File folders, DC/CV 1F, white, 11 pt. pre-numbered as per the attached shipping/imprint list. Top and side tab style.

• <u>Size:</u>

Exactly 9 ¹/₂" x 8 ⁷/₈" x 12"

• <u>Top Tab/Bar code and Case Number:</u>

1. Color stripe the entire top tab in the **Light Blue** color.

2. On the left side of top tab, print actual case number, consisting of 4-digit district code, dash, 7-digit case number code, dash, 4-digit year code 2019 in black ink.

3. On the right side of top tab, print bar code (code 3 of 9) representing case number as shown on sample.

4. The bar coded case number must have "00" inserted at the beginning of the 5-digit case number as shown on sample, and will not include dashes.

5. The case number and bar code labels must be laminated or otherwise reinforced to prevent smudges and tears.

• **Exception**: District # 06 needs to have 4th digit left blank, but with a line and will look like this "060_". However, the bar code should read "0601".

If in the process of affixing bar code labels to the folders, the vendor uses the wrong label, a new label must be created for the proper folder. Do not attempt to remove the label and tape it to the proper folder. Taping will not allow our wand scanners to pick up the bar code characters.

• <u>Side Tab and Laminated Strip Label:</u>

- 1. Color-coded strip labels or individual labels to be attached to right side tab.
- 2. Strip label or individual label must be laminated to prevent tearing or smudges.
- 3. Top label is one label for the year ($\underline{19}$), then the 5-digit case number, consecutive, beginning with 00001 for each location.
- 4. Do not include the 4-digit district code in the side labels. Note that the 2-digit year label is first on the side tab label, to read from top to bottom.
- 5. Labels are to resemble TAB Products labels to coincide with existing filing systems. Number must appear on the front and back of labels.

2.3.2 The Special Proceedings File Folders must meet the minimum specifications as follows:

• **Quantity and Size**

54,500 Shelf File folders, DC/CV 1F, blue, 11 pt. pre-numbered as per the attached shipping/imprint list. Top and side tab style.

• <u>Size:</u>

Exactly 9 ¹/₂" x 8 ⁷/₈" x 12"

• <u>Top Tab/Bar code and Case Number:</u>

- 1. Color-stripe the entire top tab in the <u>Light Blue</u> color.
- 2. On the left side of top tab, print actual case number, consisting of 4-digit district code, dash, SP, 5-digit case number code, dash, 4-digit year code 2019 in black ink.
- **Exception**: District # 06 needs to have 4th digit left blank, but with a line and will look like this "060_". However, the bar code should read "0601".

- 3. On the right side of top tab, print bar code (code 3 of 9) representing case number as shown on sample.
- 4. The bar coded case number must have "SP" inserted at the beginning of the 5-digit case number as shown on sample, and will not include dashes.
- 5. The case number and bar code labels must be laminated or otherwise reinforced to prevent smudges and tears.

- Contractor must submit sample of label and folder. The sample must be approved by the Chief Clerk of the District Court prior to awarding the bid.

2.4 DELIVERY REQUIREMENTS

• <u>Delivery:</u>

Complete and final delivery must be accomplished to all locations no later than **December 11**, **2018 FIRM**. Liquidated damages in the amount of \$100 per day for each day that delivery is not complete to each location on the shipping list will be imposed if delivery is not complete by the specified date.

• Special Note:

District #06 must be delivered using a flatbed truck so the entire pallet can be removed from truck and delivered inside building. Due to slope at the receiving dock, tractor trailers are unable to use lifts.

• INSIDE DELIVERY IS REQUIRED ON ALL DELIVERIES.

2.5 ESTIMATED QUANTITIES

AOC reserve the right to increase or decrease the number of units as required. Quantities are approximate and the unit rate bid shall apply regardless of any increase of decrease in the estimated quantities shown herein.

2.6 PAYMENT

Subject to the delivery of the product and its acceptance by the AOC, successful respondent may invoice the AOC for all appropriate charges for the product supplied. All such charges shall be derived in accordance with the prices originally quoted on the bid work sheet, attached hereto and made a part hereof. In the event that successful respondent is not in default of any of the Contract terms and conditions, then AOC shall cause said invoice to be paid timely.

2.7 INSURANCE REQUIREMENTS

- 2.7.1 The Contractor shall at all times during the term of the Contract maintain in full force and effect, the policies of insurance required by this Section. The Contractor, if requested by AOC, shall provide certified copies of any and all of the policies of insurance to AOC. By submitting a bid in response to this solicitation, the bidder warrants that it is able to provide evidence of insurance required by this section.
- 2.7.2 Evidence that the required insurance coverage has been obtained may be provided by Certificates of Insurance duly issued and certified by the insurance company or companies furnishing such insurance. Such evidence of insurance must be delivered to the AOC Office of Procurement before the actual implementation of the Contract.
- 2.7.3 All insurance policies shall be endorsed to provide that the insurance carrier will be responsible for providing immediate and positive notice to the AOC in the event of cancellation or restriction of the insurance policy by either the insurance carrier or the Contractor, at least 60 days prior to any such cancellation or restriction. All insurance policies shall name as an additional insured the Administrative Office of the Courts and the Maryland Judiciary.
- 2.7.4 The limits required below may be satisfied by either individual policies or a combination of individual policies and an umbrella policy. The requiring of any and all insurance as set forth in this IFB, or elsewhere, shall be in addition to and not in any way in substitution for all the other protection provided under the Contract.

No acceptance and/or approval of any insurance by AOC, or the Manager of Procurement, shall be construed as relieving or excusing the Contractor from any liability or obligation imposed upon it by the provisions of the Contract.

- A. The Contractor shall maintain Worker's Compensation insurance as required by the laws of the State of Maryland and including Employer's Liability coverage with a minimum limit of \$500,000-each accident; \$500,000 disease-each employee; and \$500,000 disease-policy limit.
- B. Occurrence forms of comprehensive general liability insurance covering the full scope of this agreement with limits not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for personal or bodily injuries and \$1,000,000 per occurrence and aggregate for property damage. A combined single limit per occurrence of \$2,000,000 is acceptable. All policies issued shall include permission for partial or total occupancy of the premises by or for the Administrative Office of the Courts within the scope of this Contract. Such insurance shall include but shall not be limited to, the following:
- C. Comprehensive general liability insurance including a comprehensive broad form endorsement and covering: a) all premises-operations, b) completed operations, c) independent Contractors, d) liability assumed by oral or written contract or agreement, including this contract, e) additional interests of employees, f) notice of occurrence, g) knowledge of occurrence by specified official, h) unintentional errors and omissions, i) incidental (contingent) medical malpractice, j) extended definition of bodily injury, k) personal injury coverage (hazards A and B) with no exclusions for liability assumed contractually or injury sustained by employees of Contractor, l) broad form coverage for damage to property of the Administrative Office of the Courts, as well as other third parties resulting from completion of the Contractor's services.
- D. Comprehensive business automobile liability insurance covering use of any motor vehicle to be used in conjunction with this contract, including hired automobiles and non-owned automobiles.
- E. Comprehensive Automobile Liability:

Limit of Liability - \$1,000,000 Bodily Injury \$1,000,000 Property Damage

In addition to owned automobiles, the coverage shall include hired automobiles and non-owned automobiles with the same limits of liability.

- 2.7.5 The insurance required under sub-paragraphs (A), (B), (C) and (D) above shall provide adequate protection for the Contractor against claims which may arise from the Contract, whether such claims arise from operations performed by the Contractor or by anyone directly or indirectly employed by him, and also against any special hazards which may be encountered in the performance of the Contract. In addition, all policies required must not exclude coverage for equipment while rented to other.
- 2.7.6 Any of the work under the Contract is subcontracted, the Contractor shall require subcontractors, or anyone directly or indirectly employed by any of them to procure and maintain the same coverage's in the same amounts specified above.

SECTION 3 – BID FORMAT/BASIS FOR AWARD

3.1 BID FORMAT

- 3.1.1 The Bidder must submit a transmittal letter on the bidder's stationery. The sole purpose of the transmittal letter is to transmit the bid. It should be brief and signed by an individual who is authorized to commit the bidder to the services stated in this IFB. Submit the transmittal letter with the following documents to the Issuing Office prior to the submission deadline:
 - Completed Bid/Proposal Affidavit with Resident Agent (IFB Attachment B)
 - Bid Sheets (separate IFB Attachment D) signed by authorized personnel.
 - Copies of Insurance Certificates (Section 2.7)

Bids must be submitted in a sealed envelope that clearly indicates it contains a bid.

3.2 BASIS FOR AWARD

Upon determination of the most favorable bid, review of the bid for responsiveness, and satisfaction that the bidder is responsible, the Procurement Officer shall, after obtaining all required approvals, award the contract to that bidder.

MARYLAND ADMINISTRATIVE OFFICE OF THE COURTS CIVIL AND SPECIAL PROCEEDINGS FILE FOLDERS

This Contract is made this ______ day of ______ 2018, by and between the Administrative Office of the Courts (the "AOC") in the State of Maryland and corporate name plus address (the "Contractor") with Federal Taxpayer Identification Number **XX-XXXXXX**.

In consideration of the mutual covenants and promises herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the AOC and the Contractor agree as follows:

1. <u>Scope of Contract</u>

1.1 The Contractor shall provide all Civil and Special Proceedings File Folders (hereinafter the "Goods" and /or services) in accordance with the terms and conditions of this Contract and the following Exhibits, which are attached to this Contract and incorporated as part of this Contract:

Exhibit A: Contract Affidavit

Exhibit B: Invitation for Bid dated September 05, 2018 and all amendments and exhibits thereto (collectively referred to as the "IFB")

Exhibit C: Contractor's Bid dated September xx, 2018 (collectively referred to as "the Bid")

- 1.2 If there are any inconsistencies between the contract and any of the Exhibits, the term of this Contract shall prevail.
- 1.3 The Procurement Officer may, at any time, by written order make changes in the work within the general scope of the Contract. No other order, statement, or conduct of the Procurement Officer or of any other person shall be treated as a change or entitle the Contractor to an equitable adjustment under this section.
- 1.4 Except as otherwise provided in this Contract, if any order causes an increase or decrease in the Contractor's cost of, or the time required for, the performance of any part of the work, an equitable adjustment in the Contract price shall be made and the Contract modified in writing accordingly. The Contractor must assert in writing its right to an adjustment under this section within thirty days (30) of receipt of a written change order and include a written statement setting forth the nature and cost of such claim. No claim by the Contractor shall be allowed if asserted after final payment under this Contract.
- 1.5 Failure to agree to an adjustment under this section shall be a dispute under the Disputes clause. Nothing in this section shall excuse the Contractor from proceeding with the Contract as changed.

2. Term of the Contract

The Contract resulting from this IFB shall be for a base period of three years. The State shall have the sole right to exercise up to two, one-year renewal options at its discretion. All prices for rates and terms as offered in Exhibit D are binding on the Contractor for the full term of the Contract, including renewal options.

In the event that Contractor's paper costs increase after the first year of the contract, the District Court, upon its receipt of a written notice by Contractor, requesting to pass on such increase, may elect to authorize a proportional increase of the contract price; providing, however, that such request is fully documented and supported in writing by the paper mill or paper distributor, The Contractor may only request one increase per year.

It is hereby understood by the parties that this escalation clause shall be exclusively employed for increases in paper cost, which may materialize over the duration of this Contract and may not be construed to allow any other alleged increases of operation expenses, overhead or profit, which may occur over the said duration. Contractor shall not pass on any increase of cost without the express approval of the Maryland Judiciary.

3. Consideration and Payment

- 3.1 In consideration of the satisfactory acceptance of the maintenance and repair services, the AOC shall pay the Contractor in accordance with the terms of this Contract and at the rates specified on the Bid Sheet. Except with the express written consent of the Procurement Officer, total payments to the Contractor pursuant to the original form of this Contract may not exceed \$..... (the "NTE Amount").
- 3.3 Invoices for all the Goods shall be submitted within 30 calendar days after the completion and acceptance by the AOC and shall include the following information: name and address of the AOC; vendor name; remittance address; federal taxpayer identification or (if owned by an individual) his/her social security number; invoice period; invoice date; invoice number; amount due; retainage (if applicable), and the purchase order number.
- 3.5 Additional information may be required in the future. Invoices submitted without the required information will not be processed for payment until the Contractor provides the requested information.
- 3.6 Payments to the Contractor for the services shall be made no later than thirty days after the acceptance of a proper invoice from the Contractor. Charges for late payment of invoices are prohibited.
- 3.7 In addition to any other available remedies, if, in the opinion of the Procurement Officer, the Contractor fails to perform in a satisfactory and timely manner, the Procurement Officer may refuse or limit approval of any invoice for payment and may cause payments to the Contractor to be reduced or withheld until such time as the Contractor meets performance standards as established by the Procurement Officer in accordance with this Contract. The final Contract

payment will not be made until after certification is received from the Comptroller of the State that all taxes have been paid. Final payment shall not be construed as a waiver or termination of any rights and remedies available to AOC for any failure of Contractor to perform the Contract in a satisfactory and timely manner.

4. Warranties

The Contractor hereby represents and warrants that:

- 4.1 It is qualified to do business in the State of Maryland and that it will take such action as, from time to time, may be necessary to remain so qualified;
- 4.2 It is not in arrears with respect to the payment of any monies due and owing the State of Maryland, or any department or unit thereof, including but not limited to the payment of taxes and employee benefits, and that it shall not become so in arrears during the term of this Contract;
- 4.3 It shall comply with all federal, State and local laws applicable to its activities and obligations under this Contract;
- 4.4 It shall obtain, at its expense, all licenses, permits, insurance, and governmental approvals, if any, necessary to the performance of its obligations under this Contract.

5. Non-hiring of Employees

No employee of the State of Maryland or any unit hereof whose duties as such employee include matters relating to or affecting the subject matter of this Contract shall, while so employed, become or be an employee of the Contractor.

6. Non-employment of Contractor's employees

Nothing in this contract shall be construed to create an employment relationship between AOC and any employee of either the Contractor or Contractor's subcontractors. Contractor is responsible for the acts and omissions of its agents, employees, and subcontractors.

7. Disputes

Any claim regarding the proper interpretation of this Contract shall be submitted, in writing, to the Procurement Officer, together with a statement of grounds supporting the Contractor's interpretation. Pending resolution of a claim by the Procurement Officer, the Contractor shall proceed diligently with the performance of the Contract in accordance with the Procurement Officer's decision. An adverse decision to the Contractor may be appealed by the Contractor to the Appeals Board within 15 days of the Procurement Officer's decision.

8. Maryland Law

The place of performance of this Contract shall be the State of Maryland. This Contract shall be performed, construed, interpreted, and enforced according to the laws of the State of Maryland, including State Government Article § 12-204. No action relating to this contract shall be brought in any forum other than Maryland, whether or not the AOC and State are parties to such an action.

9. <u>Amendments</u>

Except as provided in section 2, any amendment to this Contract must first be approved in writing by the Procurement Officer, subject to any additional approvals required by State law and the Judiciary's Procurement Policy.

10. Non-discrimination in Employment

The Contractor agrees: (a) not to discriminate in any manner against any person because of race, color, religion, age, sex, marital status, national origin, physical or mental disability, familial status, genetic information, gender identity or expression, sexual orientation, or any other characteristic protected by State or federal law; (b) to include a provision similar to that contained in subsection (a), above, in any underlying subcontract; and (c) to post and to cause subcontractors to post in conspicuous places available to employees and applicants for employment, notices setting forth the substance of this clause.

11. <u>Contingent Fee Prohibition</u>

The Contractor warrants that it has not employed or retained any person, partnership, corporation, or other entity, other than a bona fide employee, bona fide agent, bona fide salesperson, or commercial selling agency working for the Contractor to solicit or secure this Contract, and that it has not paid or agreed to pay any person, partnership, corporation, or other entity, other than a bona fide employee, bona fide salesperson, or commercial selling agency, any fee or other consideration contingent on the making of this Contract.

12, Non-availability of Funding

If the General Assembly fails to appropriate funds or if funds are not otherwise made available for continued performance for any fiscal year of this Contract succeeding the first fiscal year, this Contract shall be canceled automatically as of the beginning of the fiscal year for which funds were not appropriated or otherwise made available; provided, however, that this will not affect either the AOC's rights or the Contractor's rights under any termination clause in this Contract. The effect of termination of the Contract hereunder will be to discharge both the Contractor and the AOC from future performance of the Contract, but not from their rights and obligations existing at the time of termination. The Contractor shall be reimbursed for the reasonable value of any non-recurring costs incurred but not amortized in the price of the Contract. The AOC shall notify the Contractor as soon as it has knowledge that funds may not be available for the continuation of this Contract for each succeeding fiscal period beyond the first.

13. <u>Termination for Cause</u>

If Contractor fails to fulfill its obligations under this Contract properly and on time, or otherwise violates any provision of the Contract, the AOC may terminate the Contract by written notice to the Contractor. The notice shall specify the acts or omissions relied upon as cause for termination. All finished or unfinished work provided by the Contractor shall, at the AOC's option, become the AOC's property. The AOC shall pay the Contractor fair and equitable compensation for satisfactory performance prior to receipt of notice of termination, less the amount of damages

caused by the Contractor's breach. If the damages are more than the compensation payable to the Contractor, the Contractor will remain liable after termination, and the AOC can affirmatively collect damages.

14. <u>Termination for Convenience</u>

The performance of work under this Contract may be terminated by the AOC in accordance with this clause in whole or, from time to time, in part whenever the AOC determines that such termination is in the AOC's best interest. The AOC will pay all reasonable costs associated with this Contract that the Contractor has incurred up to the date of termination, and all reasonable costs associated with termination of the Contract; however, the Contractor shall not be reimbursed for any anticipatory profits that have not been earned up to the date of termination.

15. Delays and Extensions of Time

The Contractor agrees to perform this Contract continuously and diligently. No charges or claims for damages shall be made by the Contractor for any delays or hindrances, regardless of cause, in the performance of services under this Contract. Time extensions may be granted only for excusable delays that arise from unforeseeable causes beyond the control and without the fault or negligence of the Contractor, including but not restricted to acts of God, acts of the public enemy, acts of the State in either its sovereign or contractual capacity, acts of another Contractor in the performance of an AOC contract, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, or the delay of a subcontractor or supplier arising from unforeseeable causes beyond the control and without the fault or negligence of either the Contractor or the subcontractor or supplier.

16. Suspension of Work

The AOC unilaterally may order the Contractor in writing to suspend, delay, or interrupt all or any part of its performance for such period of time as the Procurement Officer may determine to be appropriate for the AOC's convenience.

17. <u>Pre-existing Regulations</u>

The applicable statutes and regulations of the State of Maryland, including those of the Judiciary, are incorporated in this Contract.

18. Financial Disclosure

The Contractor shall comply with the provisions of § 13-221 of the State Finance and Procurement Article of the Annotated Code of Maryland.

19. Political Contribution Disclosure.

The Contractor shall comply with Title 14 of the Election Law of Maryland.

20. <u>Right to Audit</u>

The Contractor shall cooperate fully with any audit conducted by the State. The Contractor shall retain and maintain all records and documents relating to this Contract for five (5) years after final payment by the AOC hereunder and shall make them available for inspection and audit by authorized representatives of the State and AOC, including the Procurement Officer or the Procurement Officer's designee, at all reasonable times.

21. Cost and Price Certification

By submitting cost or price information, the Contractor certified to the best of its knowledge that the information submitted was accurate, complete, and current as of (enter the date of the financial bid sheet). The price under this Contract and any change order or modification hereunder, including profit or fee, shall be adjusted to exclude any significant price increases occurring because the Contractor furnished cost or price information which, as of the date of the financial bid sheet was inaccurate, incomplete, or not current.

22. Subcontracting and Assignment

The Contractor may not subcontract any portion of the services provided under this Contract without obtaining the Procurement Officer's prior written approval, nor may the Contractor assign this Contract, or any of its rights or obligations hereunder, without the Procurement Officer's prior written approval. Any such subcontract or assignment shall be subject to any terms and conditions that the Procurement Officer deems necessary to protect the interest of the State. The AOC shall not be responsible for the fulfillment of the Contractor's obligations to subcontractors.

23. Indemnification

- 23.1 The Contractor shall indemnify the AOC against liability for any suits, actions, or claims of any character arising from or relating to the performance of the Contractor or its subcontractors under this Contract.
- 23.2 The AOC has no obligation to provide legal counsel or defense to the Contractor or its subcontractors in the event that a suit, claim or action of any character is brought by any person not party to this Contract against the Contractor or its subcontractors as a result of or relating to the Contractor's obligations under this Contract.
- 23.3 The AOC has no obligation for the payment of any judgments or the settlement of any claims against the Contractor or its subcontractors as a result of or relating to the Contractor's obligations under this Contract.
- 23.4 The Contractor shall immediately notify the Procurement Officer of any claim, suit or action made or filed against the Contractor or its subcontractors regarding any matter resulting from or relating to the Contractor's obligations under the Contract, and shall cooperate, assist and consult with the AOC in the defense or investigation of any such claim, suit, or action.

24. Public Information Act Notice

The AOC provides public access to records in accordance with State pursuant to §4-101 et seq. General Provisions Article, Annotated Code of Maryland, or other law relating to access to public records, including, Maryland Rules of Procedure, Rules 16-901 through 16-912. If a request is made to review any part of a proposal the Contractor may be contacted, as circumstances allow, to express its views on the availability of requested information, however, the final decision on release of any information rests with the Judiciary.

25. Conflict of Interest

- 25.1 "Conflict of interest" means that because of other activities or relationships with other persons, a person is unable or potentially unable to render impartial assistance or advice to the State or the AOC, or the person's objectivity in performing the contract work is or might be otherwise impaired, or a person has an unfair competitive advantage. "Conflict of interest" includes pending litigation in the Maryland courts.
- 25.2 "Person" includes a contractor, consultant, or subcontractor or sub consultant at any tier, and also includes an employee or agent of any of them if the employee or agent has or will have the authority to control or supervise all or a portion of the work for which a bid or offer is made.
- 25.3 The Contractor warrants that, except as disclosed in Section 25.4 below, there are no relevant facts or circumstances now giving rise or which could, in the future, give rise to a conflict of interest.
- 25.4 The following facts or circumstances give rise or could in the future give rise to a conflict of interest (Contractor: explain details-attach additional sheets if necessary; **if none, so state**):
- 25.5 The Contractor agrees that if an actual or potential conflict of interest arises after the contract commences, the Contractor shall immediately make a full disclosure in writing to the Procurement Officer of all relevant facts and circumstances. This disclosure shall include a description of actions which the Contractor has taken and proposes to take to avoid, mitigate, or neutralize the actual or potential conflict of interest. If the contract has been awarded and performance of the contract has begun, the contractor shall continue performance until notified by the Procurement Officer of any contrary action to be taken. The existence of a conflict of interest is cause for termination of the Contract as well as disciplinary action against an employee for whom a conflict exists.
