The following questions for the above referenced RFP were received by e-mail and are answered and posted for all prospective Offerors who received the RFP. Nothing in the Judiciary's response to these questions is to be construed as agreement to or acceptance by the Judiciary of any statement or interpretation on the part of the Offeror asking the question.

Question 1. Will interested parties have access to the current code baseline?

• The effort associated with conversions is typically driven by the approaches used by the original developers. Without the insight gained through a current baseline review, it would be very difficult to offer a low margin proposal.

Response: Interested parties will have an opportunity to view the back-end of the People's Law Library at the Pre-Proposal conference on Wednesday, November 13, 2013 at 9:30 A.M.

Question 2. In addition to transitioning the functionality to Drupal 7, there are requirements for the "Implementation of Responsive Design" - How will satisfaction of this requirement be adjudicated? Will there be a design review, or an approval gate for the design?

Response: See Section 2.5. There will be design review of the Responsive Design component, requiring it to function at these three breakpoint screen standard industry widths:

Narrow: 0px-519px width

Medium: 520px-959px width, and

Normal: 960px+ width.
