1) **Question:** Shall the Owner wish to have the contractor to provide as-built drawings in the latest version of auto-cad format for this project? Please confirm.

**2) Question:** Per section 2.2.3 Shall conduit pathway require for new cameras? Please confirm.

**Response: No** 

**3) Question:** Who is responsible to provide PoE Network Switch for new cameras? Please confirm.

**Response: Vendor must supply** 

**4) Question:** Per section 2.2.3 all the interior cameras are Network fixed Dome camera? Please confirm.

**Response: See camera schedule** 

**5) Question:** Per section 2.2.3 all the exterior cameras are Network fixed Dome camera? Please confirm.

**Response: See camera schedule** 

**6) Question:** Would you consider Vision Technologies to include surge protection for the exterior cameras field device and at the head-end rack-mount surge protection devices in our pricing proposal? Please confirm.

**Response: Yes** 

**7) Question:** Per section 2.2.2 is there a requirement for new cameras recording? Please confirm.

Response: All cameras must record

- 8) Question: What is the proposed resolution, frame rate, codec utilized for camera recording storage, and How many days video retention? Please confirm.

  Response: Minimum recording is 30 days.
- **9) Question:** Are there any integration between CCTV VMS with any existing security system such as access control, intrusion detection system and intercom system? Please confirm.

**10) Question:** We would like to know if any cameras will be required a lift for installation of the cameras. Please confirm.

**Response:** For installation: no; for replacement/repair – probably

**11) Question:** Per section 2.2.3, it is our understood that we shall only replace the old existing interior and exterior cameras only and use the existing pathway and existing cable. Please confirm.

Response: Yes, unless cabling is bad

**12**) **Question:** What is the manufacturer and model of camera that Owner wish to install for this project? Please verify.

**13**) **Question:** Elevator cab camera EL-03-P3 which type of existing cable had been installed? Is it coaxial RG-59U?
