## SECTION 1 - GENERAL INFORMATION

### 1.1 Summary Statement

The Administrative Office of the Courts (AOC) on behalf of Judicial Information Systems (JIS) issues this Request for Proposals (RFP) to make multiple awards for the purpose of deployment and installation of new and replacement personal computers, laptops, printers, scanners, and other related peripherals. Additional tasks could include conducting inventory surveys, software upgrades and related task. The installation will range from small deployments of one to five units up to major deployments of several hundred units.

### 1.2 Abbreviations and Definitions

For the purpose of this RFP, the following abbreviations or terms have the meanings indicated below:

- a. AOC- Administrative Office of the Courts
- b. Contract – The Contract attached to this RFP as Attachment A.
- c. Master Contractors – The awarded Offerors.
- d. Local Time – Time in the Eastern Time Zone.
- e. MBE – Minority Business Enterprise (African American, Native American, Asian Pacific, Subcontinent Asians, and Women-owned Businesses currently so certified by the Maryland State Department of Transportation), and Veteran-owned Small Businesses.
- f. Offeror – An entity that submits a proposal in response to this RFP.
- g. PORFP – Purchase Order Request for Proposal
- h. Procurement Officer – The Judiciary representative responsible for this RFP, for the determination of contract scope issues, and the only Judiciary representative who can authorize changes to the contract.
- i. RFP – Request for Proposals for **K21-0036-25B** dated **December 23, 2020** including any and all amendments.
- j. AOC Contract Manager– The Judiciary representative that serves as the technical manager for the resulting contract. The AOC Contract Manager monitors the daily activities of the contract and provides technical guidance to the Master Contractor.
- k. Judiciary business hours – 8:00 a.m. – 5:00 p.m. Monday – Friday (excluding State holidays and any other days closed by order of the Chief Judge of the Court of Appeals.).

### 1.3 Master Contract Type

The Master Contract shall be an Indefinite Quantity Indefinite Deliver (IDIQ) Fixed Price (FP) Contract.

#### **1.4 Contract Duration**

The Contract resulting from this RFP shall begin with contract execution and extend for a base period of one (1) year. The AOC shall have the sole right to exercise up to four (4) one-year renewal options at its discretion.

#### **1.8 Questions**

- 1.8.1 The Procurement Officer shall accept written questions from prospective Offerors. Please submit all questions to the Procurement Officer by e-mail (See section 1.5).
- 1.8.2 Based on the availability of time to research, the Procurement Officer shall communicate a timely answer during the pre-proposal conference. Answers to all substantive questions that are not clearly specific only to the requestor will be posted on the Judiciary's procurement website and eMaryland Marketplace Advantage.

1.8.3 All questions are due to the Procurement Officer **no later than 2:00pm (local time) on Tuesday, January 19, 2021.**

### **1.9 Proposal Due (Closing) Date**

One original and four (4) copies of each proposal (Technical and Financial) must be received by the Procurement Officer **no later than 2:00 p.m. (local time) on January 28, 2021**, to be considered. One electronic version of the Technical Proposal must be included inside the Technical Proposal submission envelope. One electronic version of the Financial Proposal must be included inside the Financial Proposal submission envelope. Both electronic versions must be labeled with the RFP title, RFP number, and Offeror's name and be packaged with the original copy of the appropriate proposal (Technical or Financial).

Requests for an extension of this date or time will not be granted. Offerors' mailing proposals should allow enough mail delivery time to ensure timely receipt by the Procurement Officer. Proposals received by the Procurement Officer after the due date and time will not be considered.

**Proposals may not be submitted by e-mail or facsimile.**

### **1.10 Duration of Offer**

Proposals submitted in response to this RFP are irrevocable for 180 days following: (1) the closing date of proposals or (2) Best and Final Offers (BAFOs), if requested. This period may be extended at the Procurement Officer's request only with the Offeror's written agreement.

### **1.11 Revisions to the RFP**

If it becomes necessary to revise this RFP before the due date for proposals, amendments will be posted on the Judiciary's Procurements webpage and on eMaryland Marketplace Advantage. Amendments made after the due date for proposals will be sent only to those Offerors who submitted a timely proposal.

**Acknowledgment of the receipt of all amendments to this RFP issued before the proposal due date must accompany the Offeror's proposal in the Transmittal Letter accompanying the Technical Proposal submittal. Acknowledgement of the receipt of amendments to the RFP issued after the proposal due date shall be in the manner specified in the amendment notice. Failure to acknowledge receipt of amendments does not relieve the Offeror from complying with all terms of any such amendment.**

### **1.12 Cancellations**

The Judiciary reserves the right to cancel this RFP; accept or reject any and all proposals, in whole or in part, received in response to this RFP, waive or permit cure of minor irregularities' and conduct discussions with all qualified or potentially qualified Offerors in any manner necessary to serve the best interests of the Judiciary. The Judiciary also reserves the right, in its sole discretion, to award a Contract based upon the written proposals received without prior discussions or negotiations.



### **1.13 Oral Presentations/Discussions**

Offerors may be asked to participate in oral presentations to expand on their proposal. The AOC expects to schedule those no later than three weeks after proposal receipt. The Procurement Officer will notify selected Offerors of the time and location.

Significant representations made by an Offeror during the oral presentation shall be submitted in writing. All such representations will become part of the Offeror's proposal and are binding if the Contract is awarded.

### **1.14 Incurred Expenses**

The Judiciary will not be responsible for any costs incurred by an Offeror in preparing and submitting a proposal, in making an oral presentation, in providing a demonstration, or in performing any other activities relative to this solicitation.

### **1.15 Economy of Preparation**

Proposals should be prepared simply and economically, providing a straightforward, concise description of the Offeror's proposals to meet the requirements of this RFP.

### **1.16 Protests/Disputes**

Any protest or dispute related respectively to this solicitation or the resulting Contract shall be subject to the provisions of the Judiciary's Procurement Policy.

### **1.17 Multiple or Alternate Proposals**

Neither multiple nor alternate proposals will be accepted.

### **1.18 Public Access to Judicial Records**

An Offeror shall give specific attention to the clear identification of those portions of its proposal that it considers confidential, proprietary commercial information or trade secrets, and provide justification why such materials, upon request, should not be disclosed by the Judiciary under Title 16, Chapter 900 of the Maryland Rules.

Offerors are advised that, upon request for this information from a third party, the Procurement Officer is required to make an independent determination whether the information can be disclosed. Information which is claimed to be confidential is to be placed after the Title Page and before the Table of Contents in the Technical Proposal and, if applicable, in the Financial Proposal.

### **1.19 Offeror Responsibilities**

The selected Offeror shall be responsible for all products and services required by this RFP. All sub-Contractor must be identified and a complete description of their role relative to the proposals must be included in the Offeror's proposals. Additional information regarding MBE sub-Contractor is provided under paragraph 1.23 below. If an Offeror that seeks to perform or provide the services

required by this RFP is the subsidiary of another entity, all information submitted by the Offeror, such as but not limited to, references and financial reports, shall pertain exclusively to the Offeror, unless the parent organization will guarantee the performance of the subsidiary. If applicable, the Offeror's proposal must contain an explicit statement that the parent organization consents to the terms of the RFP and will guarantee the performance of the subsidiary.

#### **1.20 Mandatory Contractual Terms**

By submitting an offer in response to this RFP, an Offeror, if selected for award, shall be deemed to have accepted the terms of the Contract, attached as Attachment A. **Any exceptions to the terms and conditions of the Contract must be clearly identified in the Executive Summary of the Technical Proposal. A proposal that takes exception to these terms may be rejected and therefore determined to be not reasonably susceptible of being selected for award.**

#### **1.21 Proposal Affidavit**

A proposal submitted by an Offeror must be accompanied by a completed Bid/Proposal Affidavit. A copy of this Affidavit is included as Attachment B of this RFP.

#### **1.22 Contract Affidavit**

All Offerors are advised that if a Contract is awarded as a result of this solicitation, the successful Offeror will be required to complete a Contract Affidavit. A copy of this Affidavit is included for informational purposes as Attachment C of this RFP. This Affidavit must be provided within five (5) business days of notification of proposed Contract award.

#### **1.23 Minority Business Enterprises**

Minority Business Enterprises and Veteran-owned Small Businesses are encouraged to respond to this solicitation notice. It is the goal of the Maryland Judiciary that certified MBEs and VOSB's participate.

There is no MBE Goal established for this solicitation.

#### **1.24 Arrearages**

By submitting a response to this solicitation, each Offeror represents that it is not in arrears in the payment of any obligations due and owing the State, including the payment of taxes and employee benefits, and that it shall not become so in arrears during the term of the Contract if selected for Contract award.

#### **1.25 Procurement Method**

The Contract resulting from this RFP will be awarded in accordance with the competitive sealed proposals process.

### **1.26 Verification of Registration and Tax Payment**

Before a corporation can do business in the State, it must be registered with the Department of Assessments and Taxation, State Office Building, Room 803, 301 West Preston Street, Baltimore, Maryland 21201. It is strongly recommended that any potential Offerors complete the registration prior to the due date for receipt of proposals. An Offeror's failure to complete the registration with the Department of Assessments and Taxation may disqualify an otherwise successful Offeror from final consideration and recommendation for Contract award.

### **1.27 Payments by Electronic Funds Transfer**

By submitting a response to this solicitation, the Offeror agrees to accept payments by electronic funds transfer unless the State Comptroller's Office grants an exemption. The selected Offeror shall register using the COT/GAD X-10 Contractor Electronic Funds (EFT) Registration Request Form. Any request for exemption must be submitted to the State Comptroller's Office for approval at the address specified on the COT/GAD X-10 form and must include the business identification information as stated on the form and include the reason for the exemption. ## SECTION 2 – STATEMENT OF WORK

### 2.1 Organization Background

The Judicial Branch of the Maryland State Government is responsible for the resolution of all matters involving civil and criminal law in the State of Maryland. Judges base their decisions on statutory law, common law, or equity.

Maryland has a four-tiered court system consisting of the District Court of Maryland, Circuit Courts, the Court of Special Appeals, and the Court of Appeals. The Maryland Judiciary consists of over seventy (70) physical locations throughout the State that will be considered as possible equipment deployment locations. A PORFP Request for Proposals (PORFP) will be issued and awarded addressing each actual request for service.

Located in Annapolis, Maryland, Judicial Information Systems (JIS) is responsible for facilitating the deployment and maintenance of equipment to the Judiciary locations, as well as application development and support, hardware installation and maintenance, operation of the Data Center Computer Systems, and support of online case management and business applications at the District and Circuit Courts across the state.

### 2.2 Purpose & Summary

The Administrative Office of the Courts (AOC) on behalf of Judicial Information Systems (JIS) issues this Request for Proposals (RFP) to seek proposals from prospective Offerors for the deployment and installation of new and replacement personal computers, laptops, printers, scanners, and other related peripherals on an as-needed basis.

Additional tasks could include conducting inventory surveys, software upgrades, and related tasks. The installation will range from small deployments of one to five units up to major deployments of several hundred units at multiple locations.

Through the Master Contracts awarded as a result of this solicitation, the AOC will have the flexible means of obtaining these services quickly, efficiently, and cost effectively.

The Contract will be applicable for judicial locations throughout the state of Maryland. AOC intends to make multiple awards pursuant to this RFP.

### 2.3 Master Contractor Personnel Duties and Responsibilities

**In order to be considered for the award, Offerors must clearly demonstrate in their proposals the ability to complete the following:**

- 2.3.1** The Master Contractor shall provide services in the deployment and installation of computers, removal of equipment, inventory of equipment to include site evaluation, and task - related to desktop equipment supporting court locations. Additionally, the Master Contractor may be called upon to assist with the performance of software-related activities, to include migrations, upgrades, removals and adds.
- 2.3.2** Dependent upon each Purchase Order Request for Proposal (PORFP) issued, the Master Contractor shall deploy equipment to one or several of the Judiciary locations within the State of Maryland. These include the following: Appellate Courts, Circuit Courts, District Courts, Orphans' Courts, and the Administrative Office of the Courts.  
Refer to [www.courts.state.md.us](http://www.courts.state.md.us) for more detail regarding locations of these facilities.
- 2.3.3** The Master Contractor shall follow asset management inventory control procedures set by the Administrative Office of the Courts and the District Court to ensure the assets of the court system are tracked accurately.
- 2.3.4** The Master Contractor shall provide staff, vehicles, and all required equipment such as: moving carts, and dollies for transporting, un-boxing, setting-up computers, testing, installing software and removing old computers.
- 2.3.5** The Master Contractor shall complete and process all associated project related documentation involved in the deployment process as designated by the Maryland Judiciary. This documentation shall be submitted to the Judiciary Regional Technical Lead.
- 2.3.6** For each PORFP issued, the Master Contractor shall be required to submit to the Judiciary Regional Technical Lead a list of proposed staff for background checks, identify project lead, conduct pre- deployment site survey, prepare deployment project plan based on Judiciary input, and participate in status calls, as required.
- 2.3.7** The Master Contractor's staff shall submit to and pass a background check conducted by the AOC. At all times, the Master Contractor's staff must comply with the security policies as dictated by the AOC, including but not limited to an annual background check.
- 2.3.8** The Master Contractor shall provide the initial Communication Plan, which will include a central contact number for all calls, at the kick-off meeting. The Communication Plan will be viewed as a living document and shall be updated as necessary throughout the life of the contract to ensure current information.
- 2.3.9** The Master Contractor shall always ensure the customer is left 'whole' after any work activity (i.e., requisite hardware, software, peripherals and all processes are functioning as

required). Validate with the JIS Contract Manager or his/her designated representative prior to leaving the assignment.

**2.3.10** The Master Contractor shall always employ enough qualified employees to properly and safely perform services as stated in this contract.

**2.3.11** The Master Contractor shall provide dedicated employees assigned to a PORFP for the duration of the assignment detailed in the Task Order.

**2.3.12** The Master Contractor shall adhere to the dress code and equip their employees with attire as described in the PORFP.

#### **2.4 Master Contractor Personnel Education, Skills, Experience, and Capabilities**

**For each PORFP issued, the Master Contractor shall, at minimum, propose staffing with the following:**

**2.4.1** Minimum of 3 years of formal information technology, desktop support, customer support, customer service, technology management experience.

**2.4.2** Technical training in combination with an industry certification may substitute for some or all the education requirements.

**2.4.3** Ability to communicate effectively, orally and in writing, and to establish and maintain effective working relationships with peers, end-users, as well as all levels of management and judicial personnel as necessary.

**2.4.4** Certification from CompTIA, Microsoft or HDI are a plus.

**2.4.5** Knowledge of computer hardware, architecture, repair, and troubleshooting procedures.

**2.4.6** Knowledge of Windows desktop operating systems and file systems to include Active Directory.

**2.4.7** Knowledge of TCP/IP device configuration and basic network structure.

**2.4.8** Proficient problem-solving, communication and interpersonal skills. A strong ability to learn and think critically.

**2.4.9** Be able to diffuse tense situations. Experience with dealing with people in a highly visible, fast-paced, and sometimes stressful environment. Ability to handle people in varying situations, including when users are frustrated, anxious or upset.

**2.4.10** Demonstrated customer service abilities (e.g., patience, positive customer-friendly attitude, active listening, empathy, professionalism, etc.).

**2.4.11** Strong ability to be self-motivated and self-starting. Able to control attention, minimize distractions to achieve greater efficiency. Proficient planning & organization skills - setting and managing personal priorities. Able to set priorities and handle multiple competing demands.

**2.4.12** Ability to be a team player. Demonstrate being team - oriented, ensuring that there is the respect shown for customers, team members, peers and management.

**2.4.13** Ability to ensure proper recording, and documentation.

**2.4.14 The Master Contractor shall provide resources with the following capabilities:**

- Must be able to safely lift and move pieces of hardware weighing up to 25lbs.
- May need to handle heavier pieces of equipment with additional help.
- Stooping, kneeling, and crawling may be needed for installation of equipment.
- Ability to use small hand tools as appropriate for computer installation and repair.
- Proper lifting techniques for moving equipment.
- Awareness of safety for people and equipment in the environment.
- Awareness of standard electrical and mechanical precautions.
- Hand tools, medium and large sized motor vehicles (such as vans), pneumatic pallet lift, equipment carts, hand trucks.
- Use of mobile devices as required.
- Moving and installing equipment may be in dirty, or cluttered, non-air-controlled conditions that require the employee to be cautious and aware of their surroundings.

## **2.5 Place of Performance/Work Hours**

**In order to be considered for Contract award, Offerors must clearly demonstrate in their proposals the ability to meet the following requirements:**

**2.5.1** Work assignments may be in any of the 24 Jurisdictions across the State. Refer to [www.courts.state.md.us](http://www.courts.state.md.us) for more detail regarding locations of these facilities.

- 2.5.2 Some site visits may require arranging local lodging accommodations and traveling to the region the night before the required site visit.
- 2.5.3 The Master Contractor shall be able to work all weekdays, evenings, weekends and holidays, as required for each individual project and as stated in each Task Order.
- 2.5.4 The Master Contractor shall schedule all work with the AOC's Project Manager as defined In the PORFP.
- 2.5.5 The Master Contractor 's work must be executed in such a manner that it minimizes disruption of day-to-day functions. Project site availability is often dictated by the Court's schedule. The Master Contractor may be required to stop work at any time by an officer of the court. This could happen when noise created by the installation is heard in a courtroom and may interrupt judicial proceedings. At that time, Master Contractor s and court officers will need to determine if the delay is short term or if work will stop for the day and will need to be rescheduled.

## **2.6 PORFP Procedures**

**Pre-Award: All requirements will be specifically defined for each PORFP. Award will be based on most advantageous offer and fixed price.**

- 2.6.1 The AOC will create and release a PORFP to all Master Contractors for all work activities under the PORFP. As an example, the PORFP may contain the following information:
- PORFP issue date
  - PORFP Response due date
  - Due date of work activities
  - Place of Performance
  - Point of Contact (POC)
  - Mandatory site visit date and time
  - Description of the required services
  - Description of the hours the work is to be performed (Regular business hours or after business hours on nights, and weekends or holidays)
  - Unique building delivery, parking, or other requirements specific to the facility
  - Security requirements
- 2.6.2 Upon receipt of a PORFP and after the mandatory site visit, the Master Contractor shall, prepare and submit a price proposal. The action plan and price proposal shall provide the following:



- Explanation of how the Master Contractor intends to meet the requirements of the PORFP including a detailed discussion of the work and the Master Contractor 's capabilities, approach and solution to address the requirements outlined
- Assumptions: A description of any assumptions formed by the Master Contractor in developing the proposal
- Proposed performance schedule in GANTT chart format
- Proposed number of personnel
- Proposed number of hours to complete the project
- Proposed number of days to complete project
- Sub Master Contractor s name(s) and addresses, if any
- A detailed written description of any work to be subcontracted, if any
- An estimate of staff time to be required of Judiciary employees
- Proposed personnel names with background check forms, if required
- Proposed price

## **2.7 Security Requirements**

### **2.7.1 Background Checks**

The Master Contractor shall furnish to the Contract Manager a minimum of ten days prior to commencement of work or upon issuance of a Task Order, a completed Maryland Department of General Services Authorization of Release of Information form and a Maryland Department of General Services Police Master Contractor s Security Clearance form for each person entering a Department of General Services facility for each project.

- The cost for a security badge per resource is \$15.00 payable by the Master Contractor.
- The Master Contractor shall comply with and adhere to the JIS, IT Security Policy and Standards where applicable. These policies may be revised from time to time and the Master Contractor shall comply with all such revisions. Updated and revised versions of the JIS, IT Policy and Standards are available on-line at:  
<http://mdcourts.gov/aoc/pdfs/jis-securitypolicystandards.pdf> .

### **2.7.2 IT Security**

- Security Regarding Master Contractor - owned Computer Equipment. The Master Contractor shall not connect any of its own equipment to a State LAN/WAN without prior written approval by JIS.

- The Master Contractor shall fill-out any necessary paperwork for security access to sign on at the State's site. If access to the State's LAN/WAN is granted, it will be directed and coordinated with JIS.

### **2.7.3 Physical Security**

- While on State premises, each person who is an employee or agent of the Master Contractor shall always display his or her company ID badges and be dressed in similar color clothing to represent a cohesive staffing arrangement. Each such employee or agent shall provide additional photo identification, upon request of State personnel.
- At all times and at any facility, the Master Contractor personnel shall ensure cooperation with State site requirements, which always include being prepared to be escorted.

## **2.8 Acceptance of Services**

- 2.8.1 The JIS Contract Manager or his/her designated representative has sole authority to determine the acceptable level of service.
- 2.8.2 When the JIS Contact Manager or his/her designee determines that Master Contractor Service is unsatisfactory, the Master Contractor shall return to the site at the request of the JIS, or an authorized designee, and resolve the issue at no additional cost to the AOC.

## **2.9 Damage to State and Personal Property**

- 2.9.1 The Master Contractor, their employees, sub Master Contractor s and agents shall be held directly responsible to repair, replace or restore to its original condition, to the satisfaction of the Maryland Judiciary, curbs, roadway surfaces, wheel stops, shrubbery, trees, buildings, bollards, gates, light pole, sign poles or any other State-owned property which is damaged by the actions of the above-mentioned representatives.
- 2.9.2 The Master Contractor, their employees, sub Master Contractor s and agents shall be held directly responsible for any damage caused by their action or inaction to privately-owned property and shall hold the State harmless for such damages.

## **2.10 Failure to Respond**

Should the Master Contractor fail to respond to the request for service as specified herein, the Judiciary may, at its option, directly or by contract, take whatever measures are necessary to provide the necessary services at the expense of the Master Contractor.

## **2.11 Required Policies, Guidelines, and Methodologies**

The Master Contractor shall be required to comply with all applicable laws, regulations, policies standards and guidelines affecting information technology projects, which may be created or changed periodically by the State of Maryland. The Master Contractor shall adhere to and remain abreast of current, new, and revised laws, regulations, policies, standards and guidelines affecting project execution. These may include, but are not limited to:

- The Administrative Office of the Courts Judicial Information Systems Security Policy.

## **2.12 Master Contractor Security Requirements**

Compliance with Judiciary Policies-

- A. The Master Contractor, and all Master Contractor and sub Master Contractor personnel assigned to the Contract (Master Contractor personnel), shall comply with all applicable Judiciary policies and procedures, as provided by the AOC Contract Manager, for the duration of the contract.
- B. The Master Contractor must also comply with all federal and state laws, regulations, and policies, including, but not limited to the Family Medical Leave Act and the Americans with Disabilities Act as it relates to its contract with the AOC.
- C. This includes but is not limited to the following policies: The Accommodations of Disabilities, Prohibiting Discrimination, Harassment, and Retaliation, Religious Accommodation, and the JIS Information Security Policy.
- D. The JIS Security Policy closely aligns with guidelines published by the National Institute of Standards and Technology. The Policy is available online at: <http://www.mdcourts.gov/procurement/index.html>

The Judiciary reserves the right to monitor all applicable computer and electronic equipment usage for compliance with its policies.

## **2.13 Access and Background Checks-**

- A. Site visits to any Judiciary location by Master Contractor personnel must be coordinated by Judiciary staff with the designated site personnel in advance of any visit.
- B. Any Master Contractor personnel working at Judiciary locations, or on Judiciary systems or projects, or who have access to Judiciary or State criminal data or systems, must be approved in writing by the Procurement Officer prior to beginning work.
- C. All Master Contractor personnel working at Judiciary locations, or on Judiciary systems or projects, or who have access to Judiciary or State criminal data or systems, must have a Judiciary approved criminal background check prior to beginning work with the Judiciary, and may be subject to rejection as a result of the background check.

D. All Master Contractor personnel assigned to work at Judiciary locations shall be required to obtain a Judiciary security identification badge prior to beginning work, and annually thereafter. The Master Contractor is responsible for any fees that may be incurred for initial issuance of the badge and for any replacement.

E. The badge shall be displayed at all times while on Judiciary premises. To verify identity, the Master Contractor personnel shall be prepared to provide photo identification upon request by a Judiciary official.

F. The Master Contractor personnel are required to immediately notify the AOC Contract Manager, the Administrative Official of the respective department or office or the AOC Contract Manager, if their badge is lost or stolen.

G. The Master Contractor shall obtain a Criminal Justice Information System (CJIS) State and Federal criminal background check, including fingerprinting, for each employee performing services under the Contract. An approved CJIS State criminal background check shall be completed prior to the Master Contractor personnel providing services on this Contract. The Maryland Judiciary reserves the right to refuse to allow any Master Contractor personnel to work on Judiciary premises, systems, property or contracts, based upon criminal records.

H. The Master Contractor personnel must notify the AOC Contract Manager, the Administrative Official of the respective department or office, within one (1) business day, if any personnel have been arrested, indicted, served with a criminal summons, named in a peace or protective order, or named as a defendant in any civil case. The Master Contractor personnel are also required to provide regular updated information regarding the status of any of these actions.

I. The AOC Contract Manager, in conjunction with the Deputy Director of Security Administration and the Procurement Officer, may impose restrictive conditions in response to prior criminal convictions, pending criminal charges, or a violation of Judiciary procedures, including removal from the contract, and/or restricted access to Judiciary locations or systems.

J. In the event of a security incident or suspected security incident, the Master Contractor personnel shall immediately notify the Judiciary personnel as follows:

JIS Project Manager: Ryan Swartz

K. The Master Contractor personnel shall cooperate fully in all security incident investigations.

L. During the course of the contract, if necessary, for the delivery of goods and services, the Master Contractor may be provided a Judiciary asset in the form of a cell phone, laptop, or other electronic device. Any and all Judiciary devices are the property of the Judiciary and must be returned in working, acceptable condition at the contract's conclusion. If said

devices are not in working acceptable conditions, Master Contractor may be responsible for the cost of said device(s). Any and all devices must be regularly updated as specified by the manufacturer and JIS and must adhere to all confidentiality guidelines as provided by JIS, the AOC, and the JIS Project Manager.

L. If the AOC determines that there is cause for the Master Contractor 's work to be suspended, the Master Contractor shall take the following steps:

- a. Immediately cease to represent itself as providing services to the AOC; and
- b. Deliver to the AOC: (a) a report describing the current state of the Deliverables provided by the Master Contractor under this Agreement and any applicable Statements of Work outstanding as of the date of termination; (b) all AOC Confidential information in its possession, or at AOC's option, destroy all such AOC Confidential information; and (c) all work product to the AOC within seven (7) business days as of the date of termination. Work product includes, but is not limited to, works for hire and materials as described in §29.3.
- c. Master Contractor is responsible for all AOC assets (including but not limited to, laptops, tablets, computers, cell phones, other portable electronic devices, accessories, and peripherals, etc.), that have been provided to the Master Contractor at the AOC's cost. All AOC issued assets are required to be surrendered to the AOC within five (5) business days of the termination of services. Assets will be subject to evaluation and can include normal and expected wear and tear but must be functional and operable. Assets that do not meet this condition may be subject to additional charge to the Master Contractor. Master Contractor shall be liable to the AOC for any and all assets not surrendered.

## **2.14 Access to Judiciary Information Technology Systems**

A. The Master Contractor 's personnel shall complete all required paperwork as directed for security access to the Judiciary systems.

B. The system access rights of Master Contractor personnel must be updated no later than twenty-four (24) hours after notification of the change in status; therefore, the Master Contractor shall immediately notify the AOC Contract Manager and the JIS CISO of any termination of Master Contractor personnel and immediately confiscate the Judiciary badge and return it to the AOC Contract Manager.

C. Select Master Contractor personnel may be approved and given secured remote access privileges by the Assistant Administrator, JIS, into the Judiciary systems to the extent needed for the remote access privileges that are granted. To ensure compliance with the JIS Information Security Policy, the configuration of remote access into AOC systems will be accomplished by JIS staff. The JIS staff will monitor all remote access activities.

D. The approved Master Contractor personnel may be given the capability to remotely monitor all hardware and software for error/failure notifications, as appropriate. The Assistant Administrator of JIS, must give prior written approval for the software used, and

for the method of the secured technical environment, prior to this capability being activated.

E. In the event that any approved Master Contractor personnel no longer require access to the Judiciary systems, the Master Contractor must promptly notify the Assistant Administrator, JIS and the AOC Contract Manager. The Master Contractor will be responsible for ensuring the list of authorized Master Contractor personnel is always maintained and accurate.

## **2.15 Insurance**

A. The Master Contractor shall at all times during the term of the Contract maintain, in full force and effect, the policies of insurance required by this Section. Evidence that the required insurance coverage has been obtained may be provided by Certificates of Insurance duly issued and certified by the insurance company or companies furnishing such insurance. Such evidence of insurance must be delivered to the AOC Office of Procurement before the actual implementation of the Agreement.

B. All insurance policies shall be endorsed to provide that the insurance carrier will be responsible for providing immediate and positive notice to the AOC in the event of cancellation or restriction of the insurance policy by either the insurance carrier or the Master Contractor, at least sixty (60) days prior to any such cancellation or restriction. All insurance policies shall name as an additional insured the Administrative Office of the Courts and the Maryland Judiciary.

C. The requiring of any and all insurance as set forth in this RFP, or elsewhere, shall be in addition to and not in any way in substitution for all the other protection provided under the Contract for acceptance and/or approval of any insurance by the Procurement Officer, shall be construed as relieving or excusing the Master Contractor from any liability or obligation imposed upon it by the provisions of the Contract. The limits required below may be satisfied by either individual policies or a combination of individual policies and an umbrella policy:

- i. The Master Contractor shall maintain Worker's Compensation insurance as required by the laws of the State of Maryland and including Employer's Liability coverage with a minimum limit of \$500,000 for each accident; \$500,000 for each disease for each employee; and \$500,000 for each disease per the policy limit.
- ii. Occurrence forms of comprehensive general liability insurance covering the full scope of this agreement with limits not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for personal or bodily injuries and \$1,000,000 per occurrence and aggregate for property damage. A combined single limit per occurrence of \$2,000,000 is acceptable. All policies issued shall include permission for partial or total occupancy of the premises by or for the Administrative Office of the Courts within the scope of this Contract. Such insurance shall include but shall not be limited to, the following:

- iii. Comprehensive general liability insurance including a comprehensive broad form endorsement and covering: a) all premises-operations, b) completed operations, c) independent Master Contractor s, d) liability assumed by oral or written contract or agreement, including this contract, e) additional interests of employees, f) notice of occurrence, g) knowledge of occurrence by specified official, h) unintentional errors and omissions, i) incidental (contingent) medical malpractice, j) extended definition of bodily injury, k) personal injury coverage (hazards A and B) with no exclusions for liability assumed contractually or injury sustained by employees of Master Contractor , l) broad form coverage for damage to property of the Administrative Office of the Courts, as well as other third parties resulting from completion of the Master Contractor 's services.
- iv. Comprehensive business automobile liability insurance covering use of any motor vehicle to be used in conjunction with this contract, including hired automobiles and non-owned automobiles.
- v. Comprehensive Automobile Liability (if applicable):

Limit of Liability - \$1,000,000 Bodily Injury  
 \$1,000,000 Property Damage

The Master Contractor shall maintain Automobile and/or Commercial Truck Insurance (including owned, leased, hired, and non-owned vehicles) as appropriate with Liability, Collision, and PIP limits no less than those required by the State where the vehicle(s) is registered, but in no case less than those required by the State of Maryland. *\*\*Only applicable if the Master Contractor is likely to be driving in the State under this Contract.*  
 \*\*In addition to owned automobiles, the coverage shall include hired automobiles and non-owned automobiles with the same limits of liability.

D. The insurance required under sub-paragraphs (A), (B), (C) above shall provide adequate protection for the Master Contractor against claims which may arise from the Contract, whether such claims arise from operations performed by the Master Contractor or by anyone directly or indirectly employed by him, and also against any special hazards which may be encountered in the performance of the Contract. In addition, all policies required must not exclude coverage for equipment while rented to others.

E. If any of the work under the Contract is subcontracted, the Master Contractor shall require any sub Master Contractor s to obtain and maintain comparable levels of coverage and shall provide the Procurement Officer with the same documentation as is required of the Master Contractor.

## SECTION 3 – PROPOSAL FORMAT

### 3.1 Two-Part Submission

- 3.1 Offerors must submit proposals in two separate volumes:  
(a) Volume I - TECHNICAL PROPOSAL  
(b) Volume II - FINANCIAL PROPOSAL

### 3.2 Proposals

- 3.2.1 Volume I-Technical Proposal must be sealed separately from Volume II-Financial Proposal but submitted simultaneously to the Procurement Officer (address listed in Section 1.5 of this RFP).
- 3.2.2 Submit **an** unbound original, so identified, and **four (4)** copies of each volume. An electronic version of both the Volume I- Technical Proposal and the Volume II- Financial Proposal must also be submitted.
- 3.2.3 Electronic media shall bear a label with the RFP title and number, name of the Offeror, and the volume number (I or II).

### 3.3 Submission

- 3.3.1 Each Offeror is required to submit a separate sealed package for each "Volume", which is to be labeled Volume I-Technical Proposal and Volume II-Financial Proposal, respectively. Each sealed package must bear the RFP title and number, name and address of the Offeror, the volume number (I or II), and the closing date and time for receipt of the proposals on the outside of the package.
- 3.3.2 All pages of both proposal volumes must be consecutively numbered from beginning (Page 1) to end (Page "x").

### 3.4 Volume I – Technical Proposal

- 3.4.1 Transmittal Letter: A transmittal letter must accompany the Technical Proposal. The transmittal letter shall be signed by an individual who is authorized to commit the Offeror to the services and requirements as stated in this RFP, including all addenda. Only one transmittal letter is needed, and it does not need to be bound with the Technical Proposal.
- 3.4.2 Format of Technical Proposal: Enclose **four (4)** copies and one electronic version inside the sealed package described in Section 3.3, above and an unbound original, to be so labeled. Section 2 of this RFP provides requirements and Section 3 provides reply instructions. The paragraphs in these RFP sections are numbered for ease of reference. In addition to the instructions below, the Offeror's Technical Proposals shall be organized and numbered in the same order as this RFP. This proposal organization shall allow Judiciary officials and the Evaluation Committee to "map" Offeror's responses directly to RFP requirements by



paragraph number. The Technical Proposal shall include the following sections in the stated order:

- 3.4.3 Title and Table of Contents: The Technical Proposal shall begin with a title page bearing the name and address of the Offeror and the name and number of this RFP. A table of contents for the Technical Proposal should follow the title page. *Note*: Information that is claimed to be confidential under RFP Section 1.18 is to be printed on yellow paper and placed after the Title Page and before the Table of Contents in the Offeror’s Technical Proposal, and if applicable, also in its Financial Proposal. Unless there is a compelling case, an entire proposal should not be labeled confidential but just those portions that can reasonably be shown to be proprietary or confidential.
- 3.4.4 Executive Summary: The Offeror shall condense and highlight the contents of the Technical Proposal in a separate section titled “Executive Summary.” The summary shall also identify any exceptions the Offeror has taken to the requirements of this RFP, the Contract (Attachment A), or any other attachments. Exceptions to terms and conditions may result in having the proposal deemed unacceptable or classified as not reasonably susceptible of being selected for award. If an Offeror takes no exception to the Judiciary’s terms and conditions, the Executive Summary should so state.

3.4.5 Offeror’s Technical Response to RFP Requirements:

A. General

Offerors shall address each RFP requirement in the Technical Proposal and describe how its proposed services will meet those requirements. If the Judiciary is seeking the Offeror’s agreement to a requirement, the Offeror shall state agreement or disagreement. Any paragraph that responds to a work requirement shall not merely rely on a stated agreement to perform the requested work, but rather, the Offeror should outline how the Offeror can fulfill the requested tasks in a manner that best meets the Judiciary’s needs.

B. Offerors Experience and Capabilities: The Offeror shall include information on experience with similar engagements. The Offeror shall describe their experience and capabilities through a response to the following: An overview of the Offeror’s experience providing the services.

C. References. Provide three (3) current customer references where the customer is similar in size to the RFP scope. Provide the following information for each client reference:

- i. Name of Client Organization
- ii. Name, title, and telephone number of Point-of-Contact for client organization
- iii. Value, type, and duration of contract(s) supporting client organization
- iv. The services provided, scope of the contract, and number of employees serviced.

- D. Financial Capability and Insurance: The Offeror shall include the following, for itself, and, as applicable, for any parent corporate, subsidiary or preference under RFP Section 1.19:
- Evidence that the Offeror has the financial capacity to provide the goods and/or services, as described in its proposal, via profit and loss statements and balance sheets for the last two (2) years.
  - By submitting a proposal in response to this solicitation, the Offeror warrants that it can provide evidence of insurance required by RFP Section 2.
- E. Sub Master Contractor s: Offerors must identify non-MBE sub Master Contractor s, if any, and the role these sub Master Contractor s shall have in the performance of the Contract.
- F. Required Affidavits, Schedules and Documents to be submitted by Offerors in the Technical Proposal:
- Completed Bid/Proposal Affidavit (Attachment B – with original of Technical Proposal)

### **3.5 Volume II - Financial Proposal**

- 3.5.1 Under separate sealed cover from the Technical Proposal and clearly identified with the same information noted on the Technical Proposal, the Offeror must submit an original unbound copy, four (4) copies and one electronic copy of the Financial Proposal in a separate envelope labeled as described in Section 3.3, of the Financial Proposal. The Financial Proposal must contain all price information in the format specified in Attachment E. Information which is claimed to be confidential is to be clearly identified in the Offeror's Financial Proposal. An explanation for each claim of confidentiality shall be included as part of the Financial Proposal.

## SECTION 4 – EVALUATION CRITERIA AND SELECTION PROCEDURE

### 4.1 Evaluation Criteria

- 4.1.1 Evaluation of the proposals shall be performed by a committee organized for the purpose of analyzing the Technical Proposals. Evaluations shall be based on the criteria set forth below. The Contract resulting from this RFP shall be awarded to the Offeror that is most advantageous to the Judiciary, considering price and the evaluation factors set forth herein. In making this determination, technical factors shall receive greater weight than price factors.
- 4.1.2 The Offeror shall be evaluated on the proposed services according to the specifications outlined in this RFP.

### 4.2 Technical Criteria

- 4.2.1 The criteria to be applied to each Technical Proposal are listed in descending order of importance:
- The Offeror’s demonstrated mastery of computer deployment and installation of new and replacement personal computers, laptops, printers, scanners, and other related peripherals.
  - The Offeror’s experience and capabilities, including references.
  - Technical response to requirements of RFP Section 2. The AOC prefers an Offeror’s response to requirements in the RFP that illustrates a comprehensive understanding of work requirements and mastery of the subject matter, including an explanation of how the work will be done.

### 4.3 Financial Criteria

All qualified Offerors will be ranked from the lowest to the highest price based on their total price proposed on Attachment E – Price Proposal.

### 4.4 Selection Process and Procedures

#### 4.4.1 General Selection Process:

- A. The Contract shall be awarded in accordance with the competitive sealed proposals process under the Judiciary’s Procurement Policy. The competitive sealed proposals method is based on discussions and revision of proposals during these discussions.
- B. Accordingly, the Judiciary may hold discussions with all Offerors judged reasonably susceptible of being selected for award, or potentially so. However, the Judiciary also reserves the right to make an award without holding discussions. In either case of holding discussions or not doing so, the Judiciary may determine an Offeror to be not responsible and/or not reasonably susceptible of being selected for award, at any time after the initial closing date for receipt of proposals and the review of those proposals.

#### 4.4.2 Selection Process Sequence:

- A. The first level of review shall be an evaluation for technical merit by the selection committee. During this review, oral presentations and discussions may be held. The

purpose of such discussions shall be to assure a full understanding of the Judiciary's requirements and the Offeror's ability to perform, and to facilitate understanding of the Contract that shall be most advantageous to the Judiciary.

- B. The Financial Proposal of each Offeror shall be evaluated separately from the technical evaluation. After a review of the Financial Proposals of Offerors, the Procurement Officer may again conduct discussions.
- C. When in the best interest of the Judiciary, the Procurement Officer may permit Offerors who have submitted acceptable proposals to revise their initial proposals and submit, in writing, best and final offers (BAFOs).
- D. Upon completion of all discussions and negotiations, reference checks, and site visits, if any, the Procurement Officer shall recommend award of the Contract to the responsible Offeror whose proposal is determined to be the most advantageous to the Judiciary considering evaluation and price factors as set forth in this RFP. In making the most advantageous Offeror's determination, technical shall be given greater weight than price factors.

STANDARD TERMS AND CONDITIONS**

This Contract is made this \_\_\_\_\_ day of \_\_\_\_\_ YEAR, by and between the Administrative Office of the Courts (the “AOC”) in the State of Maryland and **(Company Name)**, **(Company Address)** (the “Master Contractor”) with Federal Taxpayer Identification Number **XX-XXXXXXX**.

In consideration of the mutual covenants and promises herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the AOC and the Master Contractor agree as follows:

**1. Scope of Contract**

1.1 The Master Contractor shall provide **(Add language to fit the procurement)** (hereinafter “Goods” or “Services”), and other deliverables in accordance with the terms and conditions of this Contract and the following Exhibits, which are attached to this Contract and incorporated as part of this Contract:

Exhibit A: Contract Affidavit

Exhibit B: Request for Proposals dated **(Enter RFP Date)** and all amendments and exhibits thereto (collectively referred to as the “RFP”)

Exhibit D: Non-Disclosure Agreement

1.2 If there are any inconsistencies between the Contract and any of the Exhibits, the terms of this Contract shall prevail. If there are any inconsistencies between Exhibit B and Exhibit C, Exhibit B shall prevail.

1.3 No other order, statement, or conduct of the Procurement Officer or of any other person shall be treated as a change or entitle Contractor to an equitable adjustment under this section. Any modification to this Contract must first be approved in writing by the

Procurement Officer, subject to any additional approvals required by State law and the Maryland Judiciary's Procurement Policy and procedures.

- 1.4 Except as otherwise provided in this Contract, if any order causes an increase or decrease in the Master Contractor's cost of, or the time required for, the performance of any part of the work, an equitable adjustment in the Contract price shall be made and the Contract modified in writing accordingly. The Contractor must assert in writing its right to an adjustment under this section within thirty (30) days of receipt of a written change order and include a written statement setting forth the nature and cost of such claim. No claim by the Contractor shall be allowed if asserted after final payment under this Contract.
- 1.5 Failure to agree to an adjustment under this section shall be a dispute under the Disputes clause. Nothing in this section shall excuse the Contractor from proceeding with the Contract as changed.

## **2. Term of the Contract**

Unless the Contract is terminated earlier as provided herein, the term of the Contract is the period of **(x) year** beginning at the execution date of the Contract. The AOC, at its sole option, shall have the unilateral right to extend the Contract for up to **xx (x)**, years(s)/month(s) renewal options at its discretion. Audit, confidentiality, document retention, and indemnification obligations under this Contract shall survive the expiration or termination of the Contract.

## **3. Consideration and Payment**

- 3.1 In consideration of the satisfactory performance of the Services, the AOC shall pay the Contractor in accordance with the terms of this Contract and at the rate specified in the Request for Proposal. Except with the express written consent of the Procurement Officer, total payments to the Contractor pursuant to the original form of this Contract may not exceed \$..... (the "NTE Amount").
- 3.2 All invoices shall be submitted within thirty (30) calendar days after the completion and acceptance by the AOC for each deliverable and include the following information: name and address of the AOC; Master Contractor name; remittance address; federal taxpayer identification or (if owned by an individual) his/her social security number; invoice period; invoice date; invoice number; amount due; and the deliverable ID number for the deliverable being invoiced. Additional information may be required in the future. Invoices submitted without the required information will not be processed for payment until the Contractor provides the requested information.
- 3.3 Payments to the Contractor for each deliverable should be made no later than thirty (30) days after the acceptance of the deliverable and receipt of a proper invoice from the Master Contractor. Charges for late payment of invoices are prohibited.
- 3.4 In addition to any other available remedies, if, in the opinion of the Procurement Officer, the Master Contractor fails to perform in a satisfactory and timely manner, the

Procurement Officer may refuse or limit approval of any invoice for payment and may cause payments to the Master Contractor to be reduced or withheld until such time as the Master Contractor meets performance standards as established by the Procurement Officer in accordance with this Contract. Final payment shall not be construed as a waiver or termination of any rights and remedies available to AOC for any failure of Contractor to perform the Contract in a satisfactory and timely manner.

#### **4. Warranties**

The Master Contractor hereby represents and warrants that:

- 4.1 It is qualified to do business in the State of Maryland and that it will take such action as may be necessary to remain so qualified;
- 4.2 It shall comply with all federal, State and local laws applicable to its activities and obligations under this Contract;
- 4.3 It shall obtain, at its expense, all licenses, permits, insurance, and governmental approvals, if any, necessary to the performance of its obligations under this Contract; and
- 4.4 It is responsible for all acts and omissions of its agents, employees, and Master Contractors, including, but not limited to violations of the Non-Disclosure Agreement.

#### **5. Patents and Copyrights, if applicable**

- 5.1 If the Master Contractor furnishes any design, device, material, process, code, or other item that is covered by a patent or copyright or which is proprietary to or a trade secret of another, the Master Contractor shall obtain the necessary permission or license for the AOC's use of such item or items.
- 5.2 The Contractor shall defend or settle, at its own expense, any claim or suit against the State, AOC, or their employees acting within the scope of employment, alleging that any such item furnished by the Master Contractor infringes any patent, trademark, copyright, or trade secret. The Master Contractor also shall pay all damages and costs that by final judgment might be assessed against the State, AOC, or their employees acting within the scope of employment, due to such infringement and all attorney fees and costs incurred by the State to defend against such a claim or suit.
- 5.3 If any products furnished by the Master Contractor become, or in the Master Contractor's opinion are likely to become the subject of a claim of infringement, the Master Contractor shall, at its option and expense: (a) procure for the AOC the right to continue using the applicable item; (b) replace the product with a non-infringing product substantially complying with the item's specifications, or; (c) modify the item so that it becomes non-infringing and performs in a substantially similar manner to the original item.



5.4 If the Master Contractor obtains or uses for purposes of this Contract any design, device, material, process, code, supplies, equipment, text, instructional material, services or other work, the Master Contractor shall indemnify the AOC, its officers, agents, and employees with respect to any claim, action, cost, or judgment for patent, trademark, or copyright infringement, arising out of the possession or use of any design, device, material, process, supplies, equipment, text, instructional material, services or other work covered by any Contract awarded.

## **6. Non-hiring of Employees**

No employee of the Maryland Judiciary or any unit hereof whose duties as such employee include matters relating to or affecting the subject matter of this Contract shall become or be an employee of the Contractor, as provided under MD Code, General Provisions § 5-501, *et seq.*

## **7. Non-employment of Master Contractor 's Employees**

Nothing in this contract shall be construed to create an employment relationship between the AOC and any employee of either the Contractor or the Master Contractor 's Contractor s.

## **8. Disputes**

Any claim regarding the proper interpretation of this Contract shall be submitted, in writing, to the Procurement Officer, together with a statement of grounds supporting the Master Contractor 's interpretation. Pending resolution of a claim by the Procurement Officer, the Contractor shall proceed diligently with the performance of the Contract in accordance with the Procurement Officer's decision. An adverse decision to the Contractor may be appealed by the Master Contractor to the AOC within fifteen (15) days of the Procurement Officer's decision for adjudication pursuant to the Maryland Judiciary's Procurement Policy.

## **9. Maryland Law**

The place of performance of this Contract shall be the State of Maryland. This Contract shall be performed, construed, interpreted, and enforced according to the laws of the State of Maryland, including MD Code, State Government § 12-204. No action relating to this contract shall be brought in any forum other than Maryland, whether or not the AOC is a party to such an action.

## **10. Non-discrimination in Employment**

Master Contractor shall not discriminate on the basis of race, color, religion, ancestry, national origin, sex, age, marital status, sexual orientation, gender identity, genetic information, or an individual's refusal to submit to a genetic test or make available the results of a genetic test or on the basis of disability, or other unlawful forms of discrimination in the solicitation, selection, hiring, or commercial treatment of employees, subMaster Contractor s, Master Contractor s, suppliers, or commercial customers, nor shall the Master Contractor retaliate against any person for reporting instances of such discrimination.

The Master Contractor shall provide equal opportunity for sub-Contractors, Master Contractors, and suppliers to participate in all of its public sector and private sector subcontracting and supply opportunities, provided that nothing contained in this clause shall prohibit or limit otherwise lawful efforts to remedy the effects of marketplace discrimination that have occurred or are occurring in the marketplace.

The Contractor understands and agrees that a material violation of this clause shall be considered a material breach of this Contract and may result in termination of this Contract, disqualification of the Master Contractor from participating in AOC contracts, or other sanctions. This clause is not enforceable by or for the benefit of, and creates no obligation to, any third party. As a condition of entering into this Contract, the Contractor represents and warrants that every subcontract it has entered into or will enter into for the performance of any of the work under this Contract shall include a clause identical to the non-discrimination language above.

### **11. Contingent Fee Prohibition**

The Master Contractor warrants that it has not employed or retained any person, partnership, corporation, or other entity, other than a bona fide employee, bona fide agent, bona fide salesperson, or commercial selling agency working for the Master Contractor to solicit or secure this Contract, and that it has not paid or agreed to pay any person, partnership, corporation, or other entity, other than a bona fide employee, bona fide salesperson, or commercial selling agency, any fee or other consideration contingent on the making of this Contract.

### **12. Non-availability of Funding**

If the Maryland General Assembly fails to appropriate funds or if funds are not otherwise made available for continued performance for any fiscal year of this Contract succeeding the first fiscal year, this Contract shall be canceled automatically as of the beginning of the fiscal year for which funds were not appropriated or otherwise made available; provided, however, that this will not affect either the AOC's rights or the Master Contractor's rights under any termination clause in this Contract. The effect of termination of the Contract hereunder will be to discharge both the Contractor and the AOC from future performance of the Contract, but not from their rights and obligations existing at the time of termination. The Contractor shall be reimbursed for the reasonable value of any non-recurring costs incurred but not amortized in the price of the Contract. The AOC shall notify the Contractor as soon as it has knowledge that funds may not be available for the continuation of this Contract for each succeeding fiscal period beyond the first.

### **13. Termination for Cause**

If Contractor fails to fulfill its obligations under this Contract properly and on time, or otherwise violates any provision of the Contract, the AOC may terminate the Contract by written notice to the Contractor. The notice shall specify the acts or omissions relied upon as cause for termination. All finished or unfinished work provided by the Contractor shall, at the AOC's option, become the AOC's property. The AOC shall pay the Contractor fair and equitable compensation for satisfactory performance prior to receipt of notice of termination, less the amount of damages caused by the Master Contractor's breach. If the damages are more than the compensation payable

to the Contractor , the Master Contractor will remain liable after termination, and the AOC can affirmatively collect damages.

#### **14. Termination for Convenience**

The performance of work under this Contract may be terminated by the AOC in accordance with this clause in whole or, from time to time, in part whenever the AOC determines that such termination is in the AOC's best interest. The AOC will pay all reasonable costs associated with this Contract that the Master Contractor has incurred up to the date of termination, and all reasonable costs associated with termination of the Contract; however, the Master Contractor shall not be reimbursed for any anticipatory profits that have not been earned up to the date of termination.

#### **15. Delays and Extensions of Time**

The Master Contractor agrees to perform this Contract continuously and diligently. No charges or claims for damages shall be made by the Master Contractor for any delays or hindrances, regardless of cause, in the performance of services under this Contract. Time extensions may be granted only for excusable delays that arise from unforeseeable causes beyond the control and without the fault or negligence of the Master Contractor , including but not restricted to acts of God, acts of the public enemy, acts of the State in either its sovereign or contractual capacity, acts of another Master Contractor in the performance of an AOC contract, fires, floods, epidemics, quarantine restrictions, strikes, freight embargoes, or the delay of a Contractor or supplier arising from unforeseeable causes beyond the control and without the fault or negligence of either the Master Contractor or the Contractor or supplier.

#### **16. Suspension of Work**

The AOC may direct the Contractor in writing to suspend, delay, or interrupt all or any part of its performance for such period of time as the Procurement Officer may determine to be appropriate for the AOC's convenience.

#### **17. Pre-existing Law**

The applicable statutes and regulations of the State of Maryland are hereby incorporated in this Contract.

#### **18. Financial Disclosure**

The Contractor shall comply with the provisions of MD Code, State Finance and Procurement § 13-221.

#### **19. Political Contribution Disclosure**

The Master Contractor shall comply with Title 14 of the Election Law of Maryland.

## **20. Right to Audit**

- 20.1 The Master Contractor shall establish a reasonable accounting system, shall retain and maintain all records and supporting documents and materials relating to this Contract for five (5) years after final payment by the AOC hereunder and shall make them available for inspection and audit by authorized representatives of the State of Maryland and/or the AOC, including the Procurement Officer or the Procurement Officer's designee, at all reasonable times. The Contractor shall cooperate fully with any audits or investigations conducted by the State of Maryland and/or the AOC.
- 20.2 The AOC reserves the right, at its sole discretion at any time, to perform an audit of the Master Contractor's performance under this Contract. Auditing is defined as an independent objective assurance and consulting activity performed by qualified personnel including, but not limited to, the AOC's Internal Audit Department, to determine by investigation, examination, or evaluation of objective evidence from data, statements, records, operations, and performance practices (financial or otherwise), the Master Contractor's compliance with the Contract, including but not limited to adequacy and compliance with established procedures and internal controls over the Contract services being performed for the AOC.
- 20.3 Upon three (3) business days' notice, the Contractor shall provide the AOC reasonable access to their respective records to verify compliance with the terms of the Contract. The AOC may conduct these audits with any or all of its own internal resources or by securing the services of a third-party accounting or audit firm, solely at the AOC's election. The AOC may copy, at its own expense, any record related to the services performed and provided under this Contract.
- 20.4 The right to audit shall include the Contractor's Contractor s including, but not limited to, any lower tier sub-Contractor (s) that provide essential support to the Contract services. The Contractor and/or Contractor (s) shall ensure the AOC has the right to audit such Contractor (s).

## **21. Liability for Loss of Data**

In the event of loss of any data or records, which such loss is due to the error, negligence, or intentional act or omission of the Master Contractor, whether or not related to the performance of this contract, the Master Contractor shall be responsible, irrespective of cost to the Master Contractor, for recreating all such lost data or records in a manner, format, and time-frame acceptable to the AOC.

## **22. Subcontracting and Assignment**

The Contractor may subcontract any portion of the services provided under this Contract by obtaining the Procurement Officer's prior written approval. The Contractor may assign this Contract, or any of its rights or obligations hereunder, only with the Procurement Officer's prior written approval. Any such subcontract or assignment shall be subject to any terms and conditions

that the Procurement Officer deems necessary to protect the interest of the State of Maryland. The AOC shall not be responsible for the fulfillment of the Master Contractor 's obligations to sub-Contractor.

### **23. Novation and Assignment**

If the Contractor sells its interests in the Contract to another business entity (hereinafter "assignee"), the original Contractor must notify the AOC of the assignment within five (5) business days. The Master Contractor 's assignee and the AOC must sign a novation agreeing to continue with the original terms of the Contract. The assignee must accept all liability on behalf of the Contractor and submit the necessary documentation (i.e. Certificate of Insurance) with identical insurance coverage to the Contractor to the Procurement Officer within five (5) business days of notifying the AOC of the assignment.

### **24. Overtime**

Master Contractor s shall be paid according to the RFP. If overtime pay is not provided for in the RFP, then the Contractor shall not be provided compensation for overtime unless otherwise agreed to in advance, in writing, by the Procurement Officer.

### **25. Indemnification**

25.1. The Master Contractor shall hold harmless and indemnify the AOC from and against any and all losses, damages, claims, suits, actions, liabilities, and/or expenses, including, without limitation, attorneys' fees and costs and disbursements of any character that arise from, are in connection with or are attributable to the performance or nonperformance of the Master Contractor or its Sub Contractor s under this contract.

25.2 The AOC has no obligation to provide legal counsel or defense to the Master Contractor or its sub-Contractor s in the event that a suit, claim or action of any character is brought by any person not party to this Contract against the Master Contractor or its sub-Contractor s as a result of or relating to the Master Contractor 's obligations under this Contract.

25.3 The AOC has no obligation for the payment of any judgments or the settlement of any claims against the Master Contractor or its sub-Contractor s as a result of or relating to the Master Contractor 's obligations under this Contract.

25.4 The Master Contractor shall immediately notify the Procurement Officer of any claim, suit or action made or filed against the Master Contractor or its sub-Contractor s regarding any matter resulting from or relating to the Master Contractor 's obligations under the Contract, and shall cooperate, assist and consult with the AOC in the defense or investigation of any such claim, suit, or action.

### **26. Limitation of Liability**

Without prejudice to the AOC's right to pursue non-monetary remedies, Contractor shall be liable as follows:

- 26.1 For infringement of patents, trademarks, trade secrets, and copyrights, as provided in § 5 of this Contract;
- 26.2 For damages arising out of death or bodily injury or property damage, no limitation; and;
- 26.3 For all other claims, damages, loss, costs, expenses, suits or actions in any way related to this Contract, regardless of the form of such actions, the Master Contractor's liability shall not exceed five (5) times the NTE amount. Notwithstanding the foregoing, the Master Contractor's liability for third-party claims shall be unlimited.
- 26.4 For damages arising out of a cyber breach, defined as a breach resulting in actual or potential harm to the AOC's network, hardware, software, or other information systems.

**27. Public Access to Judicial Records**

The AOC provides public access to records in accordance with Title 16, Chapter 900 of the Maryland Rules. If a request is made to review any records pertaining to this contract, the Contractor may be contacted by the AOC, as circumstances allow, to express its views on the availability of requested information. The final decision on release of any information rests with the AOC.

**28. Conflict of Interest**

- 28.1 "Conflict of interest" means that because of other activities or relationships with other persons, a person is unable or potentially unable to render impartial assistance or advice to the State or the AOC, or the person's objectivity in performing the contract work is or might be otherwise impaired, or a person has an unfair competitive advantage. "Conflict of interest" includes pending litigation in the Maryland courts.
- 28.2 "Person" includes a Master Contractor, consultant, or sub-Contractor or sub consultant at any tier, and also includes an employee or agent of any of them if the employee or agent has or will have the authority to control or supervise all or a portion of the work for which a bid or offer is made.
- 28.3 The Contractor warrants that, except as disclosed in Section 28.4 below, there are no relevant facts or circumstances now giving rise or which could, in the future, give rise to a conflict of interest.
- 28.4 The following facts or circumstances give rise or could in the future give rise to a conflict of interest (Contractor: explain details-attach additional sheets if necessary);

28.5 The Contractor agrees that if an actual or potential conflict of interest arises after the Contract commences, the Contractor shall immediately make a full disclosure in writing to the Procurement Officer of all relevant facts and circumstances. This disclosure shall include a description of actions which the Contractor has taken and proposes to take to avoid, mitigate, or neutralize the actual or potential conflict of interest. If the Contract has been awarded and performance of the Contract has begun, the Contractor shall continue performance until notified by the Procurement Officer of any contrary action to be taken. The existence of a conflict of interest is cause for termination of the Contract as well as disciplinary action against an employee for whom a conflict exists.

**29. Ownership and Rights in Data**

29.1 In addition to the requirements stated in the RFP, the Master Contractor agrees to furnish the AOC with copies of the following: computations, computer files, data, model(s), transmittal letters, response letters, training materials, and all other documents or correspondence pertinent to the operation of **[insert type of Goods or Services]**.

29.2 The AOC shall be the owner of all materials developed under this Contract and shall be entitled to use, transfer, disclose, and copy them in any manner, without restriction and without compensation to the Contractor. Without the AOC's prior written consent, Contractor may neither use, execute, reproduce, display, perform, distribute (internally or externally), retain copies of, or prepare derivative works based on, these Materials nor authorize others to perform those acts.

29.3 The Contractor agrees that, at all times during the terms of this Contract and thereafter, all materials developed under this Contract, shall be "works for hire" as that term is interpreted under U.S. copyright law. To the extent that any of these materials are not works for hire for the AOC, the Master Contractor hereby relinquishes, transfers, and assigns to the AOC all of its rights, title, and interest (including all intellectual property rights) in such materials, and shall cooperate with the AOC in effectuating and registering any necessary assignments.

29.4 The AOC shall retain full ownership over any materials that the AOC provides to the Contractor under this Contract.

**ATTACHMENT F – NON-DISCLOSURE AGREEMENT**

**THIS NON-DISCLOSURE AGREEMENT** (“Agreement”) is made as of this \_\_\_ day of \_\_\_\_\_, 2021, by and between Administrative Office of the Courts (“AOC”) and \_\_\_\_\_ (Master Contractor”), a corporation with its principal business office located at \_\_\_\_\_ and its principal office in Maryland located at \_\_\_\_\_.

**RECITALS**

**WHEREAS**, the Contractor and AOC have entered into Contract No. **K21-0036-25B** (the “Contract”); and

**WHEREAS**, in order for Master Contractor to perform the work required under the Contract, or in the course of that work, the Master Contractor, the Master Contractor’s sub-Contractors, and the Master Contractor’s and sub-Contractors’ employees and agents (**collectively the “Master Contractor’s Personnel”**) may come into contact with information maintained or held by the Judicial branch of the Maryland government (“Confidential Information”), including the AOC and all courts, units and departments (**collectively “the Judiciary”**); and

**WHEREAS**, the Judiciary, in order to comply with the law, fulfill its various missions, and enhance the safety of participants in the judicial process, must ensure the confidentiality of certain information, and, to that end, must act as the sole entity with the authority to determine which information held by the Judiciary may be disclosed to persons or entities outside of the Judiciary; and

**WHEREAS**, Contractor acknowledges that Master Contractor’s compliance with this Agreement is a condition of doing business with AOC,

**NOW, THEREFORE**, Contractor agrees as follows:

1. “Confidential Information” includes any and all information provided by or made available by the Judiciary to Master Contractor’s Personnel in connection with the Contract, regardless of the form, format, or media on or in which the Confidential Information is provided and regardless of whether any such Confidential Information is marked as such or disclosed deliberately or inadvertently. Such information is Confidential Information, whether or not its contents may also be gathered from other sources or may subsequently be disseminated to the public. Confidential Information includes, by way of example only, information that the Master Contractor’s Personnel sees, views, hears, takes notes from, copies, possesses or is otherwise provided access to and use of by the Judiciary, whether the information relates to the Contract or the Contract has placed the Master Contractor’s Personnel in the position to receive the information. Confidential information further includes information both held by the Judiciary and derived or created from information held by the Judiciary.

2. Master Contractor’s Personnel shall not, without the AOC’s prior written consent, copy, disclose, publish, release, transfer, disseminate, use, or allow access for any purpose or in any form, any Confidential Information, except for the sole and exclusive purpose of performing under the Contract and except for disclosures to such Judiciary employees whose knowledge of the information is necessary to the performance of the Contract. Master Contractor shall limit access to the Confidential Information to Master Contractor’s Personnel who: 1) have a demonstrable need to know such Confidential Information in order to perform Master Contractor’s duties under the Contract and 2) have agreed with Master Contractor in writing to be

bound by the disclosure and use limitations pertaining to the Confidential Information. The names of Master Contractor 's Personnel are attached hereto and made a part hereof as Exhibit 1. With respect to information pertaining to the job performance, skills, or conduct of any Judiciary employee, the **only person with the need to know such information is \_\_\_\_\_**, and, except in cases of emergency involving imminent or actual bodily harm or significant property loss or damage, such information may only be disseminated to him, or, in his absence, to the State Court Administrator.

3. Contractor shall require each employee, agent, and sub-Contractor whose name appears on Exhibit 1 to sign a writing acknowledging receipt of a copy of and agreeing to comply with the terms and conditions of, this Agreement. Sub-Contractor s shall expressly agree to all of the terms applicable to Contractor. Accordingly, subcontractor s must require their employees and agents to sign such a writing and must submit those individuals' names to the Contractor for inclusion on Exhibit 1. Upon the Procurement Officer's request, Contractor shall provide originals of all such writings to the AOC. Master Contractor and sub-Contractor s shall update Exhibit 1 by adding additional names as needed and shall ensure that no employee or agent comes into contact with Confidential Information before that person has signed this Agreement. This Agreement shall not be construed to create an employment relationship between AOC and any of Master Contractor 's or sub-Contractor s' personnel.

4. If Master Contractor intends to disseminate any portion of the Confidential Information to non-employee agents who are assisting in Master Contractor 's performance of the Contract or who will otherwise have a role in performing any aspect of the Contract, Master Contractor shall first obtain AOC Contract Manager's written consent to any such dissemination. AOC's Contract Manager may grant, deny, or condition any such consent, as it may deem appropriate in the AOC Contract Manager's sole and absolute subjective discretion.

5. Master Contractor shall hold the Confidential Information in trust and in strictest confidence, adopt or establish operating procedures and physical security measures, take all other measures necessary to protect the Confidential Information from inadvertent release or disclosure to, or theft by, unauthorized third parties, and prevent all or any portion of the Confidential Information from falling into the public domain or into the possession of persons not bound to maintain the confidentiality of the Confidential Information.

6. Contractor shall promptly advise the AOC Contract Manager in writing if Master Contractor learns of any unauthorized use, misappropriation, or disclosure of the Confidential Information by any of Master Contractor 's Personnel or the Master Contractor 's former Personnel. Contractor shall, at its own expense, cooperate with AOC in seeking damages and/or injunctive or other equitable relief against any such person(s).

7. Upon the earlier of AOC's request or termination of the Contract, Master Contractor shall, at its own expense, return to the AOC Contract Manager, all copies of the Confidential Information, no matter how formatted or stored, in Master Contractor 's and/or Master Contractor 's Personnel's care, custody, control or possession.

8. A breach of this Agreement by the Contractor or noncompliance by Master Contractor 's Personnel with the terms of this Agreement shall also constitute a breach of the Contract. The termination of the Contract does not terminate Master Contractor 's obligations under this Agreement.

9. Contractor acknowledges that any failure by the Contractor or Master Contractor 's Personnel to abide by the terms of this Agreement may cause irreparable harm to the Judiciary and that monetary damages may be inadequate to compensate the Judiciary for such breach. Accordingly, the Contractor agrees that the AOC may, in addition to any other remedy available to AOC under Maryland and any applicable federal law, seek injunctive relief and/or liquidated damages of \$1,000 for each unauthorized disclosure. Contractor consents to personal jurisdiction in the Maryland State Courts and to the application of Maryland law, if AOC so elects

in its sole discretion, irrespective of Maryland's conflict-of-law rules. If the Judiciary suffers any losses, damages, liabilities, expenses, or costs (including, by way of example only, attorneys' fees and disbursements) that are attributable, in whole or in part, to any failure by the Master Contractor or any of the Master Contractor's Personnel to comply with the requirements of this Agreement, the Master Contractor shall hold harmless and indemnify the Judiciary from and against any such losses, damages, liabilities, expenses, and/or costs.
