- Notice mailed by first-class mail with a certificate of mailing at least 14 days before the first scheduled eviction date; AND 在首次驱逐日期前 至少提前14 天用带邮寄凭证的 普通邮件发出通知; 并且
- Notice posted on the premises at least 7 days before the first scheduled date of eviction. The day of mailing or posting is Day 1. Day 14 must be no later than the day before the scheduled date of eviction. Count holidays and weekends. 在首次安排的驱逐日期前至少提前7天将通知张贴在房屋上。邮寄或张贴通知的当天为第1天。第14天不得迟于安排 的驱逐日期的前一天,包括节假日和周末。

THE FOLLOWING APPLIES TO ALL EVICTIONS: When the sheriff returns possession of the property to the landlord, any of your personal property left in or around the rental unit is considered abandoned. You have no right to the property. The landlord may not put abandoned property in the street, sidewalk, alley, or on any public property. Illegal dumping of abandoned property from an eviction is a misdemeanor. Offenders are subject to a penalty of up to \$1000 per day. A landlord may transport property to a landfill or solid waste facility or donate it to charity.

You may have the right to redeem the premises by paying the amount owed plus late fees and court costs by cash, certified check, or money order. If you have received three judgments of rent due in the past 12 months, the landlord may foreclose your right to redeem the premises.
