charge for a dishonored check or money order, or, who failed to supply the Client Protection Fund a required social security number or federal tax identification number or statement that there is no such number, as indicated;

ORDERED that the clerk of this Court shall notify the clerks of the Court of Special Appeals, the several circuit courts of the counties and Baltimore City, the Chief Clerk of the District Court and the Register of Wills for each county in Maryland.
