**ORDER NISI**

The State Board of Law Examiners, after careful consideration of their qualifications, has by report to the Court recommended that the Petitioners for Admission without Examination (“OSA petitioners”) named on Exhibit A attached hereto be admitted to the Bar, conditioned upon satisfaction of the requirements of Maryland Rules 19-216(e) (Action on Petition), 19-216(g) (satisfaction of Maryland Rule 19-212 Maryland Law Component required), and 19-216(h) (satisfaction of Maryland Rule 19-213 Qualifying MPRE Score required).

It is thereupon the 2nd day of August 2021, by the Court of Appeals of Maryland, ORDERED that the Board’s recommendation be ratified, subject to the conditions therein stated, on the 1st day of September 2021, unless exceptions to the Board’s recommendation of any OSA petitioner be filed on or before said date, provided a copy of this Order be published on the Maryland Judiciary Website no later than 5 days after the date of entry and remains on the website until ratification.
