## Report on Wiretapping and Electronic Surveillance

This is the 43<sup>rd</sup> report submitted pursuant to § 10-409(c) of the Courts and Judicial Proceedings Article. The report covers Calendar Year 2021.

The Administrative Office of the Courts received reports concerning 42 requests for electronic surveillance in 2021, a decrease of 12.5% from the 48 requests reported in Calendar Year 2020. The 42 applications for surveillance were received by judges in eight jurisdictions, including 15 in Anne Arundel County, nine in Harford County, six in Howard County, four each in Baltimore City and Washington County, two in Baltimore County, and one each in Carroll and Montgomery Counties. Several investigations involved multiple wiretaps, as indicated in the accompanying tables.

During Calendar Year 2021, most reported surveillances involved investigations concerning possible violations of drug laws. Specifically, drugs - illegal was noted in 19 of the requests (45%) and narcotics in 13 of the requests (31%). The remaining requests for surveillance involved murder (four requests, 10%) or listed conspiracy as the most serious offense (6 requests, 14%) without indicating the substantive offense.

All of the reported applications for interceptions during Calendar Year 2021 involved cellular phones carried by or on an individual and more than 80% involved text messaging as well. An additional 8 included an app or social media account and seven involved microphones / eavesdropping. Five of the applications noted the application was roving with no location specified in the order, but these applications also listed a portable device carried by or on the individual as the location.

There were 160,643 total communications reported intercepted, including 24,461 (15%) of an incriminating nature. For comparison, in Calendar Year 2020, 479,544 communications were intercepted of which 51,497 (11%) were incriminating. The reported Calendar Year 2021 surveillances resulted in the interception of the communications of 5,221 individuals. While results from many investigations are still pending, and results of several investigations were unknown or unreported, thus far there have been a total of 48 arrests and 16 persons convicted. Overall, \$1,897,226 was reportedly spent on electronic surveillance, personnel, and resource costs during Calendar Year 2021. This does not include unknown or unreported costs.

Comparatively, \$869,767 was reported expended in Calendar Year 2020 and \$1,012,061 in Calendar Year 2019. In 2021, the State's Attorney for Baltimore County reportedly expended the greatest amount of money on a single investigation, \$1,178,655, followed by the Attorney General with \$268,636 expended on a single investigation. Other investigations with reported costs ranged from \$78,000 to \$134,145 in total costs reported.

A detailed breakdown of each 2021 request is appended to this report. Corresponding numbers are used to relate reports submitted by prosecuting officials to those submitted by judges.
