## Substance Abuse Disorder Assessments Ordered, HG-8-505 Calendar Year 2019

Between circuit and District Court locations, there were 1,521 substance abuse disorder assessments ordered in Calendar Year 2019. Please see breakdown by county below (Table 1).

Commentary Regarding Data Findings and Collection and Updated Calendar Year 2018 Data: In Calendar Year 2019 we are able to use more precise counting of orders through the identification and elimination of multiple evaluation codes used by certain courts. Therefore, we are updating the Calendar Year 2018, 8-505 substance abuse orders to account for use of multiple codes. In comparing updated Calendar Year 2018 and Calendar Year 2019 data, orders for evaluation between circuit and District Courts are remarkably stable. The Maryland Judiciary continues to train and educate clerks about use of these codes, particularly for courts in MDEC counties. Of note, in Calendar Year 2019, Baltimore County converted to MDEC making only three remaining counties yet to be converted to MDEC: Baltimore City, Montgomery, and Prince George's Counties. Please see below for specific notes regarding each case management system.

*Montgomery County Circuit Court* – The Quality Control Division confirmed that the numbers provided are the number of granted orders. They attested that the count is of court orders, not unique cases or defendants.

*Prince George's County Circuit Court* – A query was run through docket text and comments to get total number of assessments ordered as no code existed to properly identify these orders. New codes have been created in Prince George's case management system to report a more accurate total moving forward.

**Baltimore City Circuit Court** – Confirmed that the number provided is the number of orders, not the number of defendants.

**District Court Mainframe** – As referenced in the Judiciary's Calendar Year 2019 and Calendar Year 2018, 8-505 legislative reports, a new code identifying 8-505 orders was implemented in the District Court Mainframe in May of 2017. However, to control for any instances in which the code was not utilized and to ensure all 8-505 orders were captured, several data queries were run through docket text and comments to get a total number of assessments ordered.

*MDEC (Circuit & District Court)* – MDEC "Event Listing" report was run for Calendar Year 2019 to identify the frequency of codes indicating in-custody assessments. This process does not necessarily return all 8-505 orders in counties operating on MDEC as problems have been identified in pinpointing the out-patient assessments due to code mapping from UCS to MDEC. The number of 8-505 orders were added across case management systems for those counties that transitioned to MDEC.
