

**POOL CANDIDATES**  
*for Judicial Vacancies*

Pool candidates are individuals who were nominated by a Maryland Judicial Nominating Commission but who were not appointed to a judgeship by the Governor. These individuals remain in a “pool” for automatic consideration by the Governor for future vacancies on that court level and jurisdiction.

Pool candidates remain in the pool for two (2) years from their interview date with the Commission. A pool candidate’s eligibility is based upon the date the vacancy occurs (i.e., previous judge’s retirement date).
