

**POOL CANDIDATES**  
*for Judicial Vacancies*

Pool candidates are individuals who were nominated by a Maryland Judicial Nominating Commission but who were not appointed to a judgeship by the Governor. These individuals remain in a “pool” for automatic consideration by the Governor for future vacancies on that court level and jurisdiction.

Pool candidates remain in the pool for two (2) years. *As of May 6, 2019, a pool candidate is eligible for any vacancy which occurs within two years of the date of the appointment for which they were originally nominated.*
