A Practical Approach to Legal Reference

Traditional legal research training has focused on foundational materials - statutes, cases, regulations, and legal treatises. While these remain important, this guide takes a more practical approach. It's designed to help public library staff:

- Recognize when a question has a legal dimension
- Respond with appropriate information and resources
- Navigate complex topics without providing legal advice

Rather than focusing solely on in-depth legal research, this training prepares you to assist with the real-life legal questions that patrons bring to your desk every day.
