## Updating Personal Details

### Quick Reference Card

#### Overview



The Attorney Information System (AIS) is an online, secure, and comprehensive information database for Maryland lawyers. It is critical that personal details are kept up to date. As part of the annual reporting process, attorneys are required to verify their Federal EIN (Tax ID) number every year. Take the following steps to log into AIS, view, and verify your current Tax ID information.

#### Updating Personal Details

- Log into AIS at <https://jportal.mdcourts.gov/aisattorneyportal/security/login.xhtml>.
- On the Home Page, the **Compliance Summary** tab will display. To edit the Federal EIN (Tax ID) information, click the **Start/Edit Personal Info** button in the Action column.
