# Attorney Information System (AIS) Uniform Statewide Subpoena Form Quick Reference Card

## **Overview**

Pursuant to Rules 2-510, 3-510, 4-265, and 4-266, the Maryland Judiciary implemented a uniform, statewide sunpoena form, **effective July 1 2015**. To ensure the required seal and the appropriate clerk's signature appears on each subpoena, separate versions of the form are provided for each circuit and district court. The content of all versions is the same.

**NOTE**: A subpoena may be served ONLY within 60 days after it is issued. If not served within the 60-day period, it must be reissued for service.

### **Requesting a Uniform Statewide Subpoena Form**

- 1. Log into AIS at <u>https://jportal.mdcourts.gov/aisattorneyportal/security/login.xhtml</u>.
- 2. From the **Menu** on the left side of the window, select the **Uniform Statewide Subpoena Forms** option.
