

Addendum No. 1 Fleet Vehicle GPS and Camera System K22-0071-25

The purpose of this addendum is to amend and clarify certain portions of the above-referenced solicitation with all prospective bidders/offerors.

Ouestions:

- Q1. Can you provide a current vehicle list?
- A1. Current vehicle list is attached to this addendum.
- **Q2.** What fleet management software does this system need to interface with?
- A2. We do not have any software this system needs to interface with.
- **Q3.** What is the evaluation weighing of the proposals?
- A3. 60% technical, 40% financial.
- **Q4.** Would a response be "non-compliant" if the bid proposal does not include removal of existing equipment?
- A4. Successful Offeror must remove existing equipment.
- **Q5.** Who is the current service provider?
- A5. LB Technology.
- **Q6.** How many vehicles require a camera solution?
- A6. All vehicles require a camera solution.
- Q7. Section 1: S.R.5 Is a third party issued compliance report mandatory (AICPA Service Organization Control (SOC) 2 compliant, or equivalent (e.g., ISO 27001/2 Certification, Verified PCI DSS, FedRAMP)), or would an internal security description be acceptable?
- A7. An internal security description is acceptable.
- **Q8.** Is there an anticipated scope beyond this or is this the entire fleet?
- A8. This is the entire fleet, with the potential for occasional additions throughout the life of the contract.
- **Q9.** What is considered "Weather resistant and designed for rugged use"?
- A9. Proposed equipment must be able to withstand Maryland weather and temperature variations.
- **Q10.** Can you provide a quick overview of the use of the vehicles? Who are using the vehicles? What is getting transported?
- A10. Vehicles are used by Judiciary personnel for work related travel. Occasionally smaller equipment/tools may be transported.
- Q11. Is facial blurring a requirement?
- A11. No.

- Q12. Is 6 months of storage of all video a strict requirement?
- A12. It is a preference.
- Q13. Please confirm that the ability of the camera to "wake up" and record when the ignition is off based on an event such as an impact is a new requirement.
- A13. The AOC prefers a solution that allows for a "wake-up" feature in the event of an impact while the vehicle is off.
- Q14. Please provide more details on the battery back-up requirement.
- A14. The AOC prefers a solution that offers a battery back-up to support the "wake-up" feature.
- Q15. Do you want a full removal of all cabling or can they be cut and tucked?
- A15. Full removal.
- Q16. Can the (3) copies of each volume be bound?
- A16. All copies shall be unbound.
- Q17. Attachment I is required for Subcontractors, but there is no Attachment I included in the RFP.
- A17. Attachment I is included with this addendum.
- **Q18.** Are there any other agencies within the State of Maryland that can piggyback from this contract? Are there any other States whose agencies can piggyback from this contract?
- A18. This contract is intended for Judiciary use only.
- **Q19.** Is there an existing Cellular Data Plan in place?
- A19. No.
- **Q20.** Do you have a dedicated server to download and store the recorded video?
- A20. No.
- **Q21.** Section III.F.1.b. mentions installation, transfer and/or removal within three business days, please confirm that does not apply to initial installation.
- A21. Confirmed.
- **Q22.** Is the bidder responsible for disposing the existing system?
- A22. No.

All addenda will be incorporated into the final contract documents and will be binding on all bidders/offerors responding to this solicitation. Each bidder/offeror submitting a bid/proposal must acknowledge receipt of all addenda by completing and forwarding Attachment H (included in bid/proposal package) with the bid/proposal response; failure to acknowledge addenda may result in the bid/proposal rejection.
