## I. ELIGIBILITY CRITERIA

The following jurisdictions in Maryland are eligible for funding under the Maryland Problem-Solving Court Risk/Need Screening Pilot Program:

- All Maryland Circuit Courts with an Adult Drug Court (ADC) and/or Veterans Treatment Courts (VTC)
- All Maryland District Courts with an Adult Drug Court (ADC) and/or Veterans Treatment Courts (VTC)
- All eligible courts must be converted to the MDEC Case Management System

# III. FUNDING OPPORTUNITY DESCRIPTION

**Background:** In December 2021, OPSC was awarded \$1,699,219 from the Federal Bureau of Justice Assistance (BJA) to increase access to adult drug and veterans treatment court programs for high-risk/high-need non-violent offenders with substance use disorder and to acquire a new problem-solving court management information system to improve data collection and performance monitoring. <u>Please see Maryland's Federal grant award information</u> for the <u>FY</u> 2021 Adult Drug Court and Veterans Treatment Court Discretionary Grant Program.

**Federal Subgrants for Risk/Need Pilot Program – \$710,000:** As part of the federal grant award described above, the Office of Problem-Solving Courts (OPSC) is providing notice of subgrant funding availability (NOFA) for the implementation of universal pre-adjudication risk and need screening of all non-violent criminal defendants in up to six jurisdictions<sup>1</sup>. The term "violent offender" means a person who is (1) charged with or convicted of an offense that is punishable by a term of imprisonment exceeding one year, during the course of which offense or conduct (A) the person carried, possessed, or used a firearm or dangerous weapon; (B) there occurred the death of or serious bodily injury to any person; or (C) there occurred the use of force against the person of another, without regard to whether any of the circumstances described in subparagraph (A) or (B) is an element of the offense or conduct of which or for which

amount of \$710,000 is available for distribution among the six chosen jurisdictions and throughout the life of the grant. The goal of this program is to expand participation of high-risk/high-need court involved individuals with substance use disorder in adult drug court (ADC) and veterans treatment court (VTC) programs; improve processing time efficiency of referral and entry to ADC and VTC (NADCP Best Practice); and increase demographic diversity of referrals to ADC and VTC.

**Pilot Program Overview:** Following a determination of eligibility per the BJA violent offender guidelines, or determination of military status, and the opportunity to consult with defense counsel (if representation has not been waived), pilot jurisdictions will utilize the Risk and Need Triage (RANT) screening tool to identify high-risk/high-need offenders (as defined by NADCP best practice for target population) for referral to ADC an/or VTC. Individuals screened as low-risk/high-need should be referred to community-based substance use disorder treatment. Individuals not identified as high need should be referred to the appropriate community service as indicated by the screening tool.

RANT Administration: The RANT screening tool may be administered using paper and pencil/pen or electronically using your program's RANT screening software application. Screenings administered electronically can be conducted via a smart tablet or desktop computer. Please note, smart tablets will be provided to subgrant awardees and do not need to be factored into subgrant funding requests.

Adult Drug Treatment Courts Violent Offender Eligibility Screening: The Bureau of Justice Assistance (BJA) is providing funding for this pilot program. Per their guidelines, individuals must be determined to be eligible under the BJA violent offender prohibition **prior to** receiving a RANT screening. The violent offender eligibility screening must occur as a separate screening and may not be included as part of the RANT. Please see footnote<sup>2</sup> at the bottom of this page for an explanation of the guidelines and <u>Appendix A</u> for all applicable offenses in Maryland.

Veterans Treatment Courts Military Status Screening: Please note, VTCs are not necessarily subject to the violent offender prohibition<sup>3</sup>. Military status must be confirmed prior to administration of the RANT.

**Deliverables:** In alignment with the goals of the program and consistent with NADCP best practices, participating jurisdictions are expected to produce the following deliverables:

- expand participation of high-risk/high-need non-violent offenders with substance use disorder in adult drug and veterans treatment court programs
- improve processing time efficiency of referral and entry to ADC and VTC (NADCP Best Practice)
- increase demographic diversity of referrals to ADC and VTC.
